

The cost of such portions to said improvements as are local im-provements shall be assessed to the extent of special benefits upon properties found to be especially benefitted thereby in accordance with th laws of the State of Nebraska, which assessments, when collected, shall be set aside and constitute a sinking fund for the payment of said bonds. The City shall cause to be levied and collected annually upon all the taxable property in the City, a tax, which, together with such sinking fund derived from the special assessments, shall be sufficient to meet payments of interest and principal of said bonds as the same become due, said tax shall be known as a "Sewer Tax" and be payable

annually in money. Section 7. There shall be and there is hereby created in said City of Plattsmouth, Nebraska, a sewer district known as "San-itary Sewer District No. 7," the outer boundaries of which are as follows:




