



Supt. T. I. Friest, announced Friday that the Plattsmouth schools have set the age requirement for kindergarten enrollment for the 1954-55 school year, at five years, following the uniform legal standard throughout the state.

Mr. Friest stated, "The age requirement for entrance to Kindergarten has become uniform throughout the State. It is now a legal requirement that children who wish to enter the Kindergarten for the first time must have attained the age of five years on or before October 15th. The only exceptions will be for those children who will have satisfactorily completed Matur-ity Tests under the direction of the State Superintendent of Public Instruction, administered under the supervision of the County Superintendent.
