The esteem in which the dean of local businessmen is held was shown as the entire audience ose as one to give the 91-yearold founder of Soennichsen's Store a standing ovation.

The ovation followed a clearheartfelt laudatory address A. H. Duxbury, Lincoln, one of "dozens of young men" Mr. Soennichsen "helped to realize some of the values in life we might have overlooked if it were not for our association with binu

Those were some of the words Duxbury, manager of the Veteans Administration Office in ncoln and county judge here some 20 years, used in telling of the honored guest's career in Plattsmouth.

Duxbury said that two words often used by Mr. Soennichsen's plainly show the character of the man. He said that in the years, beginning as a "green" boy from Missouri in 1907, in which he worked for Mr. Soennichsen he had never known him to give an instruction or an order in his store but what it was concluded with the words "Will you?"

Since 1889 when he went into ousiness here, Mr. Soennichsen has helped dozens of youngsters to further their eduction and their lives, Duxbury said.
