## COMMISSIONERS PROCEEDINGS

Office of County Commissioners Cass County, Plattsmouth, Neb. February 5, 1963

Board met pursuant to adjournment. Present Harold R. Gregg, Melvin R. Todd and H. L. Bornemeier, Commissioners and Chas. Land, County Clerk. Minutes of the last session approved and the following business transacted in regular form. Fees for the month of January were reported by the following officers:

Clerk of Dist. Court	\$ 171.50

The Board met with Mr. Glen Noble in regard to locating a place for the unemployment to meet. It was decided to try the lower floor of the Courthouse for the next meeting and if this works out, they will meet there for the time being.

Representatives for the Lincoln Telephone & Telegraph Co. met with the Board in regard to laying cable in the road bed from Union Corner East and South to the Otoe County line. This matter was held over until some changes were made in the contract.

A petition was sent in from Greenwood in regard to appointing a Justice of the Peace and after some discussion a Resolution was drawn up and signed appointing Mr. Jack L. Fritch, said appointment to be effective forthwith upon and continue qualifying by filing bond and said appointment to continue until the next General Election and until a successor is elected and qualified.

The Board also discussed former Sheriff Solomon's inventory and it was decided to call Mr. Solomon in for further discussion.
