A Crucifixion of Justice.

Dietrich goes free. The situation is passing strange. Charged with a monstrous breach of official honor, affecting not his own good name alone, but that of a great state as well, he was arraigned for trial before a court composed of men of profound learning and steadfast integrity.

The letter of the law has been upheld. There can be no doubt of that. But to the plain understanding of plain men it must seem that the spirit of the law has been crucified.

We have no the means nor the wish to pronounce upon the accused man's guilt or innocence. But the people were entitled to know the truth.

Look at the matter as it stands. Whatever the consequences of his acts might have been, Dietrich escaped upon the plea that when those acts were done he had not taken the oath of office and so was not, in strict speech, a member of the senate.

Hereafter any man may be elected a senator, may be looked upon and honored by the people as such, may enjoy the high dignity of office, may exercise its mighty influence, may be countenanced by state and nation in his axalted station, may use his title and his newly bestowed voice and power in any way he will, save in the actual and formal affairs of the senate chamber, and yet, if he will but postpone the taking of his formal oath, he may sell his prestige in the open market to the highest bidder and escape scathless.

We do not question the action of the court, but rather the status of a system of jurisprudence which made the action inevitable.

There is something wrong with the system of jurisprudence. It looks as though there were specks of decay upon it. Shall we be obliged to go back to the beginning and start afresh?—Omaha News.

THE BOXING CONTEST.

The sport loving people of Valentine were treated to some good boxing bouts last Saturday night. The program consisted of three bouts; two four rounds each, and one of ten rounds, and everyone that attended seemed to be well satisfied.

The first bout was a preliminary between Kid Richardson, of Fort Niobrara, and Kid Donovan, of Hot Springs. At 8:45 the two men appeared in the ring and were introduced by W. A. Kimbell, the referee.

Round 1—A few seconds were spent in long range sparring but were not long in getting together. Donovan feinted with right and caught Richardson a hook on the jaw with left.

Round 2—Both exchanged lefts for face. Donovan rushed and landed a good punch in the wind, but on getting away slipped just as Richardson caught him a terrific left uppercut on the jaw.
