



Hospital Patients Greatly Benefited by a Kind-Hearted Player.





KANSAS NOW A LIQUOR SAHARA.

Bucket Shops Kicked, Streams Purified, Danny Dreamer Barred.

Kansas is as dry as laws can make it now. The new prohibitory law that stops the sale of liquors by druggists went into effect at midnight Saturday. The Kansas statute book appeared Saturday morning, and the acts of the Legislature become effective on its publication. All bucket shops in the State will have to close. The new labor law bars child actors from the theaters and all boys under 14 years of age from the messenger service. Interurban cars must be equipped with additional conveniences. Cities will be required to preserve the purity of the waters of the streams in their vicinity. Railroads will be required to erect hog tight fences along the right of way where farmers require it. 
