During a Month Farmers Will be Given a Course of Advantage at Lincoln-Soils, Seed Corn, Animal Husbandry and Other Data.


Lincoln, Dec. 13. - The winter course in agriculture begins January 2, and closes March 3. Instruction is offered in the following subjects: Field crops and farm management, dairying, diseases of animals, hortiand English.

The course is a thoroughly practical one designed for those young men who

The structure and composition of the soil is studied in an elementary way so that the student may have an idea of what substances compose the soil and how they are related to one another, also that he may see that the soil is not a mass of inert material but that it teems with myriada of microbe organisms. The various properties of the soil are studied and the effect of different methods of soil treatment upon these properties. In other words it is attempted to teach the principles of the subject, rather than to write down hard and fast rules for handling the soil. No two soils are accepted. 


