## Call for Republican State Con-

vention. The Republican electors of the State of Nebraska are hereby called to send Delegates from the several Counties to meet in State Convention at Columbus. on Wednesday, the 19th day of May, 1880, at 7 o'clock p. m., for the purpose of electing six delegates to the Repubof electing six delegates to the Repub-lican National Convention to be held at Chicago, on the 3d day of June next, to nominate candidates for President and Vice President of the United States; and to transact such other business as may properly come before it.

The several Counties are entitled to representation in State Convention as follows, based upon the vote cast in County for Hon. Amasa Cobb for Judge of the Supreme Court, in 1879, giving one delegate to each 150 votes, and one for the fraction of 75 votes, also one delegate at large for each organized County.




