That section six of said ordinance be amended so as to read as follows: Section 6. The license tax herein provided for shall be a perpetual lien upon all the property, real and personal, of the person, firm, company or cor-poration owing the same. Said license tax may be collected by the city treasurer at any time after the same becomes due by distress and sale of personal property; and in making such dis-tress and sale he shall proceed substantially in the manner provided by statute for the collec-tion of ordinary taxes on personalty. The council may, by resolution, at the time provided by law, certify to the county clerk the amounts due and delinquent for license tax under the provisions of this ordinance which amounts shall be placed on the proper tax list to be col-lected in the manner provided for the collection of cther taxes. The money due or to become due under the provisions hereof may also he collected by civil action in the name of the city before any court of competent jurisdiction. sefore any court of competent jurisdiction. SECTION 3. Sections two and six of said o linance as heretofore existing are hereby r pealed. SECTION 4.
