

One concern today was still using the quotations under a temporary injunction, but this case comes up on court tomorrow, when ounsel for the board will present arguments for its dissolution. In view of Judge Kohlsaat's decision enfoining a number of local bucket shops from using the board's quotations, the directors expect another victory.

Want to Bar Out Americans.
