Summer School Arrangements.

The manager of the summer school is meeting with a gratifying response from the heads of departments in his efforts to secure courses. All seem to realize that now is the time to establish the permanence of the summer school as a successful branch of our University work, and much depends upon next summer's showing. School Inspector J. W. Crabtree has agreed to organize a course in school management, in which six or eight of the most noted principals and superintendents of the state will take part. All will be under the direction of Mr. Crabtree, who will also lecture. His unexcelled facilities for learning the needs of public school teachers makes him a desirable man to conduct such a course, and the manager of the summer school considers its success already assured. Professor Richards is working on plans for a course in manual training, which shall meet the growing needs of teachers in this direction. The inquiries coming to him indicate that there is a real demand for practical instruction in the manual arts.

Dr. Bessey has been urged to give lectures in three summer schools the coming summer. He has about decided to accept the invitation from the school at Colorado Springs, Colo., although the matter is not definitely settled. The lectures are to be given in buildings erected on the famous Garden of the Gods, between Colorado Springs and Manitou, and under the shadow of Pike's Peak.

Laws in Legal Tangle.

The jurists of the law school have been deeply concerned in legal matters since the first of the year, but now one of their cases is becoming celebrated for its duration and the magnitude of the interests involved. For several weeks an equity case involving a large tract of land, in which the fortunes of many are at stake, has been under fire in the district court. Last Saturday the case occupied the entire day and continued until 11 o'clock at night without any conclusion in sight. With Judge Armstrong on the bench, and Attorneys Craft and Davis appearing for the plaintiff, and Attorneys Buchanan and Shuman in the defense, the case has been bitterly fought, complications being constantly augmented by the plaintiffs' bringing in bills, mechanics' liens, mortgages, etc. It is hoped that this case, which has attracted much attention, will be settled by next Saturday evening.

Music in Chapel.

Chapel time this morning will be devoted to a musical production of unusual excellence. "In a Persian Garden," a song recital adapted Omar Khayyam's "Rubaiyat," will be rendered by Mrs. Holyoke, Mrs. Baker, Mr. Johnston and Mr. Gillespie.
