**Editorial Remarks**

Unless ordered discontinued The Daily Nebraskan will be sent the coming semester to all present subscribers.

We have been beset by inquiries as to why we have not taken steps to expose and to give publicity to the case of petty larceny that has just been aired in the city police court by University parties. Although it is well for an example to be made in cases of this kind, in order to deter others from the same practice, yet we do not believe that it is our place to give extensive publicity to incidents of this nature. The story of another's degradation as set forth in the columns of a newspaper may appeal to those who are morbid-minded enough to take an eager interest in such things, but we would certainly hesitate to put our readers in this class. The workings of justice are sufficiently severe to teach the wrongdoer a lesson, but we do not believe that he can be driven to reform by castigating him through the newspapers.

We might have profited by the opportunity to obtain a piece of news by setting forth the disgrace of a fellow student in order that our readers might regale themselves for a moment with the account of his downfall, but have refrained because we do not see why a man should be pursued with persecution after the law courts have dealt with him and exacted the penalty of his offense. True, such petty larceny as does occur in this University is to be regretted, but there are other means of limiting it than by making public exploitation of the person's disgrace when he is caught. For news of affairs of this kind finds ready circulation among our student body, and if there are others eligible to profit by the example made, they will have sufficient opportunity to take warning and discontinue their practices in the future.

It is right that an example should be made, but it must be made by the proper parties. If proper care is taken by the proper authorities and by students these cases of larceny will not be so frequent. But if any cases are detected then it is the duty of those duly concerned to see to the punishment of the offenders, as has been done in the present instance. The law is sufficient to properly punish any criminal and there is no reason why one of our own student body should be considered as a common enemy after he has been banished from our midst, bearing a heavy burden of humiliation. We advocate a careful lookout for cases of this kind and the meting out of just punishment, but beyond that we are not concerned. The student who appropriates the property of another is conscious of the penalty that will be exacted of him if discovered, and the mere perusal of what is likely

to happen if he is found out will not have any great effect in deterring him from pilfering if he gets the chance. A rigorous lookout is necessary and summary action in all cases detected. This is the only way the nuisance can be stopped, for such means will compel a change of program on the part of the individual concerned, when he would not heed the threats made through the columns of any newspaper.

The band concert next Monday evening should be attended by all University people. The good work done by the band this year has commended it to all, and any enterprise in which it is concerned should receive our united support. It has rendered invaluable service in the football games on our athletic field and given many excellent concerts in chapel. And also, the object it has in view in giving this concert is deserving of special consideration. It hopes in this manner to raise enough money to redeem its pledge to the Temple Fund, or at least a share of it. Such a purpose is certainly a laudable one, as any movement aiming to help out the Temple Fund should receive our united support. There are two deserving causes to be served and we hope that cognizance will be taken of this fact, and that the crowd may be in proportion to the excellent services that the band has rendered.

The baseball outlook is decidedly good. Although some of the veterans are missed, there is a sufficient number of the old men here to furnish a nucleus around which to build. In practice a large number of new men have been showing up well and some have displayed unusual promise. The leading candidates for the box are men who have had lots of experience and have made good records on some of the strongest teams in the state, and in this department the team will be very strong. It will not be necessary to take novices and break them in for any position. If ever the prospects for a winning team here were unusually good, now is that time, judging from the early season form that has been shown.
