

ment ,etc., shall be selected from the class that graduates the year of the publication of the annual.

Two managing editors who will assist the editor as he shall direct shall be chosen from the class that graduates in the year succeeding the publication of the annual.

One managing editor to be chosen from the senior class of the Law School, as that school sees fit, who will have general charge of the Law department. This managing editor, together with the president of his class, will select his staff from the Law School and from time to time make such changes therein as he sees fit.

The artists will be selected by the editor-in-chief in consultation with his three managing editors and with the business manager.

The ordinary board of litterateurs shall be chosen jointly from the two upper classes.

II. Business Management.

The business management shall consist of one business manager chosen from the senior class, with two assistants from the junior. (Wherever the words "senior class" are used in this plan they shall be understood to mean the class that graduates in the year of publication of the annual. The words "junior class" shall mean the class that graduates the succeeding year.)

The above board shall have full and complete charge, except as such is curtailed in these resolutions, of the management of the book.

III. Selection of Board.

The editor-in-chief shall be nominated by the president of the senior class after consultation with the faculty. This appointment shall be invalid unless confirmed by a majority of the class. If the president's first nomination is rejected he shall continue nominations until an acceptable person is named. This nomination shall be made as early as practical in February of the year before the annual is to be published.

The business manager shall be chosen in the same manner from the same class until someone acceptable to the president, class and editor-inchief is secured. The appointment of any business manager shall be invalid unless ratified by the editor-in-chief.

The managing editor shall be selected in a similar manner from the class that graduates in the year succeeding the publication of the annual, but such selections shall be invalid unless ratified by the editor-in-chief. If, after eight trials, it shall appear that there is a deadlock between the selecting class and the editor-in-chief, that editor and the president of the selecting class shall choose the managing editors.

The two assistant business managers shall be chosen in a similar manner from the same class, the appointment to be ratified by the business manager.

The remainder of the staff shall be selected from the two classes jointly by the editor-in-chief and the managing editors in consultation with the two respective class presidents. The editor-in-chief shall make such changes as he sees fit from time to time in the portion of the staff thus selected.

IV. General Management.

The business manager shall keep or cause to be kept a set of books showing all receipts and expenditures to date. Such books shall at all times be open to the inspection of the faculty auditing committee. If this committee should discover an attempt to

deliberately falsify this account, the class recommends that the guilty party or parties be expelled from the University and that such notice of expulsion be posted on the bulletin boards.

After all bills have been settled and all other members of the board receive compensation which is just and reasonable under all due circumstances, the balance shall be divided between the editor-in-chief and the business manager. In all questions of due compensation the faculty auditing committee shall be final arbiter, but the above division of proceeds is recommended to it.

We recommend that if the faculty auditing committee sees fit to punish graft or embezzlement by expulsion, such expulsion and the cause thereof be made public. Be it further

Resolved, That upon passage of the above resolutions that the secretary of the senior class is hereby instructed to procure and deliver copies of the same with a statement of the action of the class of 1906 upon them, and with a recommendation for like action upon their part to the presidents of the junior, sophomore and freshman classes, and also to the presidents of the senior, junior and freshman law classes of the University of Nebraska.

#### Names Committee.

President DeYoung of the junior class has appointed a committee to consider the resolutions passed by the seniors yesterday. This committee is to report to the class at a meeting to be held next Tuesday morning. The committee is as follows: C. A. Sunderlin, A. E. Wolfe, Dale Drain, T. C. McWilliams and H. G. Myer.


