



SQUAD MEMBERS MET SATURDAY AND ORGANIZE.

To Be Known as The Forum-Constitution is Adopted and Officers Elected.

Nebraska is no longer without a de bating club. At a meeting of the varsity squad held in the Trophy Room Saturday evening an organization, to be called The Forum and to be composed of University debaters, not to exceed twenty-five in number, was perfected, a constitution adopted and the following officers elected for the ensuing semester:

C. C. McWhinney, president.

G. M. Tunnison, vice-president.

A. C. Hough, secretary-treasurer.

By a provision in the constitution he members of the debating squad for 1906 were made charter members of the new organization. They are: C. C. McWhinney, E. C. Marvin, J. M. Swenson, C. A. Sunderlin, G. M. Tunnison, J. T. Miller, J. L. Clark, Mason Wheeler, R. A. Bates, H. W. Craig, J. O. Wentworth, A. C. Hough, S. M. Rina ker and A. M. Levy.

The club will hold its first regular meeting next Saturday night in Memorial Hall when the Wisconsin-Nebraska debate will be discussed, the first team probably illustrating how the Badgers "put it to Nebraska" by using the Madison-system on the second team.

The collowing is the constitution as adopted by the club:

ARTICLE I.

Name.

The name of this organization shall be "The Forum."

> ARTICLE II. Purpose.

The purpose of this organization shall be the cultivation of the art of public speaking and debate.

ARTICLE III.

Membership.

Section 1. The membership shall not exceed twenty (20) male students of the University of Nebraska who exhibit special interest in public speaking and debate and have shown special aptitude for that work.

Sec. 2. By the unanimous consent of all members present the membership may be increased to twenty-five

Sec. 3. All members of the University debating squad of 1906 who evidence the intention to co-operate actively in the work of this organization shall be constituted charter members.

Sec. 4. Perspective membership shall be in the hands of a committee of five to be appointed by the president at the beginning of his term and to continue in office during said term.

Sec.' 5. To secure admission, candidates shall file an application for membership with the chairman of the membership committee, secure a majority vote of the committee, and receive the favorable vote of two-thirds of all members.

Sec. 6. By a two-thirds vote of the total membership any member may be dropped from the roll for a justifiable cause. When such action is contemplated, the member shall be notifled b ythe secretary, and shall, if he desires, have opportunity to show cause why he should not be thus ex pelled.

ARTICLE IV.

Officers. The officers and their duties shall

be as follows: Section 1. A president, who shall preside at all meetings and exercise

general duties of a presiding officer.

exercise the duties of the president in his absence.

Sec. 3. A secretary-treasurer, who shall keep the records and have general supervision of the finances.

ARTICLE V.

Program Committee.

Section 1. There shall be a program committee of three members appointed by the president at the commencement of his term to continue during such term.

Sec. 2. This committee shall select topics for discussion, appoint speakers thereon, and announce each program on the bulletin board at least two weeks in advance.

Sec. 3. Whenever it is practicable, this committee shall secure the services of a competent critic for each debate.

> ARTICLE VI. Amendments.

Section 1. Amendments to this constitution must be submitted one week prior to passage, and at such meetings must secure a majority vote of all members present. At the next meeting the proposed amendment must secure a two-thirds vote of the total membership to be incorporated in the constitution.

Sec. 2. The by-laws may be amended in the same manner.

BY-LAWS.
