While Childs made a very favorable impression upon the members of the board and of the student body at large, his name has not come before the board for action and probably no decision will be rendered until the first of the week. Some of the other candidates may be invited to come to Lincoln to meet the athletic authorities before any vote is taken on the coach proposition.
