'Nebraskan' Publishes Student Council Constitution, By-Laws for Assembly

Constitution was adopted by vote of the student body, May 14, 1931.

We, the students of the University of Nebraska, with the consent of the Uni-versity Scante, do hereby ordain and ca-tablish this Constitution for the adminis-tration of student affairs.

The name of this organization shall be The Student Council of the University of Nebraska.

ARTICLE II

The purposes of this organization shall be to act as the supreme student governing body in the regulation and coordination of all phases of student self-government and extra curricular activities and to serve as an agency through which faculty relationships with student activities may be maintained.

ARTICLE III

Section I. The Student Council shall have the following powers so far as in the exercise thereof these powers do not conflict with general university regulations.

To regulate and coordinate the activities of all student organizations and whenever such activities are of general university interest;

To recognize and approve the consti-tutions of any new student organizations, without which recognition and approval no such organization shall be permitted to

function;

3. To have complete control of student
peo railies, similar forms of pep demonstrations, and student migrations.

4. To conduct all student elections which
are of general university interest and in
which popular voting is used;

5. To review all such rollings of student
bedies as may affect the social conduct
and well-being of the students.

6. To serve as a mittable medium for
communication between the student body
and university authorities;

7. To legislate in such a manner as shall
be necessary and proper for carrying into
execution the foregoing powers and all
other powers that may be vested in the
Student Council.

Section II. The decisions of the Student Council, made in pursuance of it constitutional powers, shall be carried into
execution by the appropriate faculty or
student executive or group. The Student
Council shall have the power to suspend
or dismiss from office any student executive, who shall refuse to carry its legilist in into effect.

2. Any student, orpanization, or member
of the faculty or the university may appent to the appropriate committee of the
University Senate whonever he foets that
the Student Council has either exceeded or
misappied its power or has assumed an
univarranted jurisdiction. In such saves,
the committee shall permit both the complaining party and the Council to be
beard, after which the decisions of the
committee shall be taken to carry out that
ruling pending the decision of the approppriate Senate Committee.

L. a. Each understratuate college or school wishing a representative on the Student Council shall have one member regardess of the size of the college or school. When the minority group has a membership between 601 and 1200 it shall be given another member. PREAMBLE

Section III. To be eligible for membership in the Student Council candidates must meet the following requirements;

1. Each candidate shall be a bona fide member of the college, school, or class which he proposes to represent. Regular university rules shall govern in determining a candidate's college, school or class.

2. Each candidate shall have a scholastic average of at least 75 percent for all preceding semester.

tic average of at least 75 percent for all preceding semester.

Section IV. Nominations for the class and college representatives of the Student Council shall be made by the filing of the name of the candidate not later than 5 p. m. on Friday prior to the day of election, at the office of Student Activities. The secretary of the Council shall amounce in the columns of The Daily Nebrankan, at least ton days prior to the day upon which filings close, the time when filings hall be made.

Section V. 1. Election of members to the Student Council shall be by a system of proportional representation.

2. The Student Council set forth requirements for the recognition of student parties of factions. No party or faction shall have the right to file candidates until such party or faction has been recognized by the Student Council.

2. Each party or faction shall file a list of its candidates for memberships in the Student Council in the Student Activities office not later than 5 p. m. on Friday prior to the day of election, such lists to be made up in the caucuses of the respective parties or factions.

4. The ballots shall list the names of the several candidates for office and shall designate after each candidate's name the party or faction to which that candidate belongs.

5. There shall be given to each qualitied student voter a separate ballot bearing the names of the various parties or factions which have been permitted to file candidates for office. Each student voter shall be privileged to designate his party preference on this ballot.

6. Each party or faction shall be entitled to one member on the Council for every 125 votes cast in that party's favor on the party ballots.

7. After the results of the election are computed, the representation in the Student Council shall be apportioned as follows:

a. If, in the election, any party or faction shall be apportioned as follows:

a. If, in the election, any party or faction shall be increased until it has one member for every 125 votes which that party polled on the party ballots.

b. When the representation of any party is so raised, those of its candidates in the clection who have the nignest number or votes shall be declared elected to the Council—for example, if a party is entitled to two additional places, the two highest unsuccessful candidates in the election shall be made members of the Council.

c. If any party should in the election secure more than one place for each 125 votes cast in its favor, then that party shall be entitled to retain the advantage as secured.

S. In all cases a major fraction of 125 shall constitute a unit of representation.

9. Nothing in this constitution shall be reacconstructed as to deprive any student of the right to file as an independent candidate.

ARTICLE V

A meeting of the newly elected Student Council shall be called by the outgoing chairman within ten days after the election

ARTICLE VI

Variancies in the Student Council shall be filled by the Student Council. Members chosen to fill vacancies should in every case be members of the same sex, class, and college as were the original members.

ARTICLE VII

Section I. Mass meetings of the students shall be called by the president of the Stadent Council at the discretion of the Council or upon written request of fifty students of the university.

Section II. Students may present to the Council in writing or in person any proposal or grievance at any regular meeting.

ARTICLE VIII

Section I. The Student Council shall be known as the Student Council Judiciary committee which shall be known as the Student Council Judiciary committee.

4. To arrange for the delegation of the administration of Council rulings to other organizations and groups when authorized to do so by the Council;

5. To insure that enforcement powers delegated to other organizations or groups are properly executed.

6. In all cases the action of the Judiciary Committe shall be final except for appeal to the proper University Senate Committee.

ARTICLE IX

It shall be the duty of the secretary of the Council to cause to be published in the columns of the Dally Nebraskan a full account of the official actions of the Coun-cil as soon as those actions take place.

ARTICLE X

Amendments to this constitution or revision of it may be submitted to the student body for adoption at any regular student election or at a special election called for that purpose. The Council shall submit amendments for the approval of the student body when such requirements have been pussed by a two-thirds vote of the Council members or upon the petition of not less than 100 students. Proposed amendments must be published in The Daily Nebraskan at least ten days tefore the election at which they are submitted. A majority of the vote cast thereon is sufficient for the passage of an amendment, after which it must be ratified by the University Senate.

BY-LAWS

Section 1. Regulation and coordination of

ctivities: 1. The Student Council is empowered to ass upon the actions of lesser University rganizations.

Each year the Student Council shall evaluate all campus organizations to de-termine whether they have fulfilled their purposes and potentialities.

The Student Council shall make recom-mendations and shall suggest constructive programs to University organizations.

4. The Student Council has the power to appoint delegates to certain boards. The procedure of making such appointments shall be as follows:

a. The right to apply shall be granted to all eligible students. The time and place of filing shall be adequately publicized by official student newspaper.

b. A committee shall be created to review applicants and to make recommendations on their individual qualifications to the Student Council.

c. The Student Council, acting as a body, shall have final jurisdiction over such appointments.

Section II. Constitutions of University
Organizations and Activities.

1. No organization or activity shall exist as a University approved function or
body without the approval of its constitution by the Student Council.

c. The constitution is referred back to the Council for approval or rejection.

d. No constitution shall be rejected without a specific statement of its deficience, nor shall the approval of a Constitution be denied after the necessary alternious have been effected.

e. New organizations must submit a report clearly showing the necessity for their creation.

3. The Constitution Committee of the Student Council may examine constitutions of existing organizations, and supon such examinations may recommend coordination and combination of conflicting bodies, or revoke constitutions of conflicting bodies, or revoke constitutions of conflicting bodies, or revoke constitutions of organizations and student migrations.
