Pfeifer Endorsed

Ron Pfeifer and Dick Schulze are the only two serious candidates for president of ASUN in the Daily Nebras-

Both of these candidates are presently senators and both have shown themselves worthy of holding a high student office. Both also stand for a meaningful and responsible student government.

Better President

However, in the Nebraskan's opinion, because of experience, personal ideals, leadership and direction Ron Pfeifer would definitely make the better president of the two candidates.

Pfeifer was elected as a freshmen to Senate and has been a member of ASUN for two years. In his first year he was one of the only two sophomore committee chairmen. During his junior year, he has been student welfare chairman, a member of the Ad Hoc Housing Committee and a member of the ASUN executive committee.

Pfeifer as a member of the Lincoln Recreation Board is the youngest person involved in Lincoln city government and as far back as high school, he was president of the Nebraska High School Student Council Association.

Schulze has served one impressive year as a senator, committee chairman and executive member. He has also been a member of the Student Court.

New Idea

The Student Bill of Rights today is a pretty well accepted necessity for student government - most students support the rights bill. But at this same time last year, the bill was a new idea and like many new ideas candidates were afraid to support it.

Pfeifer was one of the few candidates who imediately recognized the bill as an idea that could help Nebraska, students and their government. He ran on a ticket strongly supporting the formation of such a bill in last year's election and he has supported the idea ever since.

He was one of the first students to realize that a responsible Nebraska student government could use the bill in a responsible way. He realized at that time long before the Daily Nebraskan or for that matter most students that a bill of rights did not have to mean

marches or demonstrations, but rather could be used at Nebraska to make a rational student government more meaningful, helpful and representative to the

Schulze must also be praised for his support of the bill and there is no question, but that he has devoted more work than any other student to making the bill today a reality. However, in the last several months, Schulze has shown confusion about what the bill represents. Rather than try to explain to people the rational principles behind the bill and the responsible government it could promote, he has concentrated on making the bill look weak so it will offend no one.

Outstanding Leader

Pfeifer - the Outstanding Collegiate Man - must be described as the outstanding leader in the junior class. His leadership since his freshman year has established a new kind of outstanding student on the University campus. While several years ago the outstanding student may have been a person who offended no one and stuck very closely to status symbols and tradition, Pfeifer has helped to establish the new 1967 outstanding student who thinks for himself, who has opinions and who isn't afraid of new ideas and change.

Pfeifer has lead the University in realizing that intellectuals and radicals who are greatly separated from the rest of the school are not the only students who can think, who can strive for improvement in society and who can support new ideas.

All ASUN executive candidates are urging students to vote for the Student Bill of Rights. The Daily Nebraskan joins these candidates in stressing how important it is that as many students as possible vote for the bill.


The bill represents the work of many students and administrators this year. The future of student government will hopefully continue to brighten as ASUN improves next year with the bill.

Law Student Writes . . . **Explanation Of Housing Proposals**

(EDITOR'S NOTE: The different housing proposals to be voted on Wednesday, original Article 5, the al-ternate Article 5 and the additional separate housing amendment, have created a great deal of confusion. The Daily Nebraskan asked John Klein, a senior in the University Law College, to write his interpretation of the three proposals. Klein was closely involved with University's student government when he was an undergraduate and worked on the ASUN Constitution.)

Appearing on the ballot April 12 are three proposed amendments to the ASUN Constitution which relate to the students' role in selection of their housing. The amendments recite as follows:

1. The Original Article 5 Students have the right to choose their own living

environments. 2. An Alternate Article 5 Students have the right to an equitable role in for-

mulation of housing policy which allows maximum individual choice. 3. A Separate Amendment

Each student shall have the right to choose his living environment.

The question which immediately arises with respect to the original and alternate is whether "students" is a collective term or whether it means "each student." If "students" is a collective term in these articles the next question

is whether ASUN is granted a power to establish housing policy since ASUN is the official voice of the students collective-

More Precise In the original Article 5 it would appear that "students" is used to mean "each student." If this be the case the original article and the separate amendment are identical in meaning. Thus anyone supporting the original on this thesis would instead vote for the separate Article 5 as a more precise statement of the same

meaning. The danger of voting for the original Article 5 is that it may also afford a grant of power to ASUN to establish housing policy. Thus one voting for the original thinking that it meant that each student could select his own housing may find that rather he has given ASUN the power to regulate housing.

Likewise one who casts his ballot for the original thinking that he has given the students collectively through ASUN the power to establish housing policy may find to his amazement, that he has not done this at all, but rather has voted to give each student individually the right to select his own housing.

Affords Nothing The alternate Article 5 appears more than likely to mean "students collectively" perhaps via ASUN, perhaps not. However, it is in its entirety so vague as to be almost devoid of any significant meaning. Administration could easily

housing policy including the present one, that students are receiving all that this amendment requires and perhaps more. A provision as vague as this affords nothing and secures nothing. It is in this

respect harmless. The threat of a vague provision such as alternate Article 5 is that no one knows what it really means. It may pop up at some later date in some entirely unintended application.

The phrase "formulation of housing policy" found in this amendment no doubt has a different, probably a much broader meaning than the right to choose ones own living environment and could easily be interpreted to include womens regulations.

Women's Hours Thus if "students" means "s,t u dents collectively through ASUN" and "formulation of housing policy" includes womens' housing rules this amendment could be interpreted to extend to ASUN the power to regulate women's hours. It may have other applications.

The crux of the whole matter is that this amend-ment is too vague and ambiguous to be seriously urged for incorporation into any meaningful bill of

With respect to the question of whether "students" means "each student" or whether it is a collective term the other provisions of the bill of rights are of little help. From one article to another "students" has a shifting meaning. Sometimes it appears to mean "e a c h student," sometimes students collectively through ASUN and sometimes students collectively outside of ASUN. Fully Explored

In brief a completely voluntary non-discriminatory housing policy can be drawn up so as to meet all the goals of administration and the students alike. This viewpoint and perhaps others has not been fully explored.

It is the function of student government to make investigations and ASUN is structured and prepared to do just that, ASUN has not however been given the opportunity to function in the students behalf. By student approval of the separate Amendment which states "Each student shall have the right to choose his own living environment" ASUN can under new leadership perform that function and negotiate with administration for that end

Liz Aitken

Liz Aitken is the Daily Nebraskan's choice for ASUN first vice president.
