## remodeling tabled

The proposed renovation on the first floor of the Nebraska Union was rejected last night at the Union Board meeting. The Women's restroom and study lounge will stay as is-at least for a year.

The controversial segment of the recommendation proposed selling the space now occupied by the women's lounge and restroom to businesses.

Union Director Allen Bennett moved to table the recommendation until the new board takes over next semester. The term of the present board would end, he said, before being able to act effectively.

Bennett said he realized the reaction to the remodeling issue had "caused ourselves (the Union Board) and our staff some concern." The \$130,000 project had merit as a catalyst for further long-range remodeling in the Union, he said.

UNL student Dan Hughes asked Bennett why he had "switched in mid-stream." He questioned why Bennett brought up the proposal at the last Union Board meeting if he realized that planning could not be effectively taken up this semester.

Bennett said the planning would be best handled by a new "unencumbered" board. The additional work was "accomplishable" earlier in the semester but not now, he said.

In making such a proposal "you have to assume lead time," he said. "You immediately give yourself six to eight months before anything's done.'

The Union-which is student supported-is not run by an "executive fiat," board member Jim Balters said. Students would complain, he said, if the staff "sat around and gathered dust."

"I think students should be glad the Union is working," Balters said.

## FAB hears requests

Fees Allocation Board heard three requests for student fees Thursday night. Decisions were delayed by the board until November 24th.

Brian Waid, president of the Student Bar Association, asked that the board provide financial assistance to the Minority Recruitment Program. According to Waid, the program's function is to provide information to disadvantaged students from Nebraska about the LINL Law School.

Due to a lack of funds, the effectiveness of the program has been severely limited, Waid said.

Last year the program was able to travel throughout the state speaking to minority students in junior colleges and in high schools. Because of a lack of money this year, they have been unable to do so, said Waid.

The board also heard a request from Outreach, the University crisis line for personal and emotional problems. Due to a budget cut by the legislature, however, Outreach has been forced to cut back its operation despite an increase in service and in personnel from last year, said Debbie Cady, a student coordinator of Outreach.

In addition to the crisis line, Outreach provides speakers to outside groups.

The UNL Ski Club also has asked that student fees be provided for its organization. The organization is presently financed entirely by its members. Club treasurer Paul Oppegard said that the four-year-old organization has doubled its membership in the past year. There are now over 150 members, he said.

The purpose of the ski club is to make skiing trips easier and cheaper for students who otherwise would have a more difficult time going, said Oppegard.


