Mao dies

Tokyo-Chairman Mao Tse-tung died Thursday, plunging China into an uncertain political future and leaving a gaping hole in the leadership of the world's most populous nation. As if anticipating a power struggle for Mao's mantle, the Central Committee of the Communist party issued an appeal for unity. In a statment, the committee pledged to "carry on the cause left behind by Chairman Mao."

Resolution passes

Washington-The Senate passed a budget resolution Thursday projecting a deficit of \$50.8 billion for the 12 months beginning Oct. 1. The House was at work on a separate but similar resolution calling for a deficit limit of \$50.7 billion, \$3.2 billion greater than the revised budget estimates of the Ford administration. A conference to adjust Senate-House dif-ferences was set for Friday.

Smith urges

Washington-Rep. Virginia Smith, R-Neb., has urged President Ford to strip the State Department of its authority to negotiate voluntary restraint agreements with countries exporting meat to the United States. Instead, the Chappell lawmaker wants that power switched to the secretary of agriculture. In a letter to the President, Mrs. Smith said the negotiation responsibility was originally placed with the secretary of agriculture, and "this is where it belongs,"

Unrest mounts

Johannesburg, South Africa-Police gunfire Thursday killed an 8-year-old boy as mobs of mixed race and black Africans went on a rampage of violence, arson and looting in the Cape Town area, At least

13 persons have been killed in three days of demonstrations and rioting against the white government. Armed police escorted white motorists in convoys in the Cape Town area.

Two face suit

Omaha-Sorensen Construction Co., Inc., of Omaha Thursday sued for money it said is owed for excavating the sunken Bertrand steamboat at the DeSoto National Wildlife Refuge near Missouri Valley, Iowa.

Jesse Pursell and Sam Corbino, both of Omaha, were named in the suit. The suit alleges that the defendants recieved \$39,000 for artifacts and other materials recovered and that the defendants received other compensation for vials of mercury recovered in the excavation, for which Sorensen received \$648. The suit said the defendants owe Sorenson 25 per cent of all compensation received, because of an agreement with Sorensen to excavate the Steamboat site.

Nebraska's day care programs will receive more federal money, but how much and whether any of it goes to the University Child Care Project is not yet known.

President Ford Tuesday signed into law a bill adding \$240 million to the \$600 million which states receive for day care

According to Ed Schulenberg, chief of the division of social services for the State Department of Public Welfare, Nebraska will receive some of the money. But he said Thursday that day care is under a state plan, and he wasn't sure the additional money would alter that plan.

Under the plan, student parents on a

four-year program must pay a fee regardless of whether they qualify for assistance based on state income regulations.

Mary Jo Ryan, director of the Unversity Child Care Project, called the restriction a "discriminatory clause against college students."

"Their excuse has always been that they don't have the money. Now that they do we'll just have to wait and see what they do with it," she said.

The University Child Care Project lost \$2,800 in state funds this year as a result of a \$500,000 cut in the NU administration budget.
