ASUN requests records

The ASUN senate voted unanimously Wednesday night to request that Young Americans for Freedom and the Nebraska University Public Interest Research Group furnish their 1977-78 meeting minutes to the senate.

The minutes will be used by ASUN's Special Topics Committee in their investigation of the two groups' compliance with student organization guidelines. The committee submitted the bill.

In other business, the senate passed a resolution 19-12, recommending to the Union Board that the ASUN office be moved to first floor.

"How many students come to us to say it's not accessible?" questioned Marvin Kleeb, business senator.

"They might realize that ASUN is around," responded Jay Yost, teacher's college senator.

"I was one of the people that worked day and night to get the office in the shape it is now," said Bob Gleason, arts and science senator, regarding recent renovations

"We have very good space up there now

and we don't have any business kicking around the people who are down here," Gleason said.

Another proposal drawing much controversy would have installed the three senate members of the executive committee as ex-officio members on all but the four standing committees.

Drafter of the bill, Teacher's College senator Toni Ecklund said the bill was aimed at giving the ex-officio members non-voting status and no committee priveleges.

Parliamentarian Charles Fellingham quoted Robert's Rules of Order, however, stating that ex-officio members have "all the rights of members and none of the responsibilities of members." Those rights include making motions and voting, Fellingham said.

After discussion about the direction the bill should take it was postponed indefinitely by a 24-4-2 vote.

Other motions passed Wednesday night permitted ASUN executives to authorize petty cash expenditures of under \$25 per executive each month.
