The article did not mention the several fire alarms pulled by the childish rampage—although it turned out later that those alarms were needed.

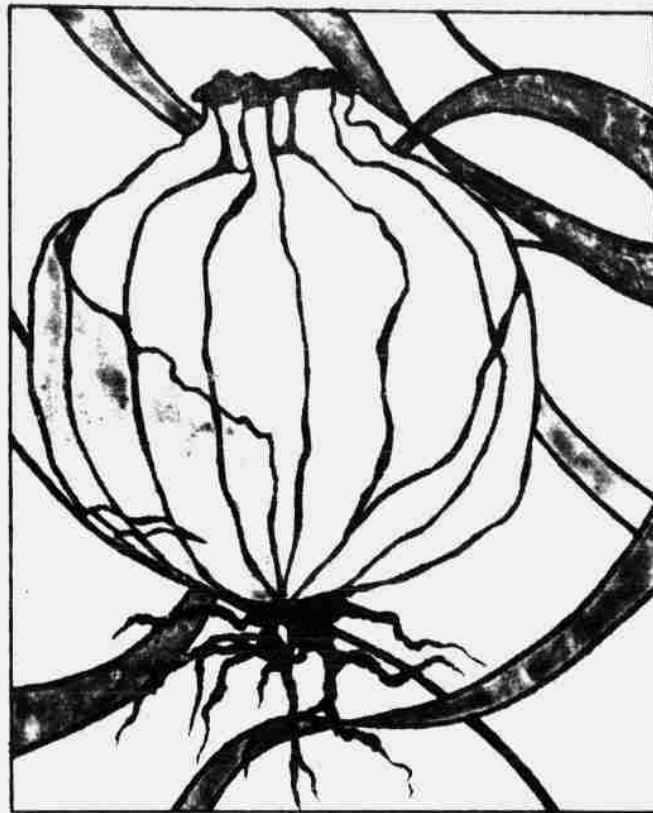
Instead, the reader was treated to eight paragraphs on Mike Phillips and his bravado.

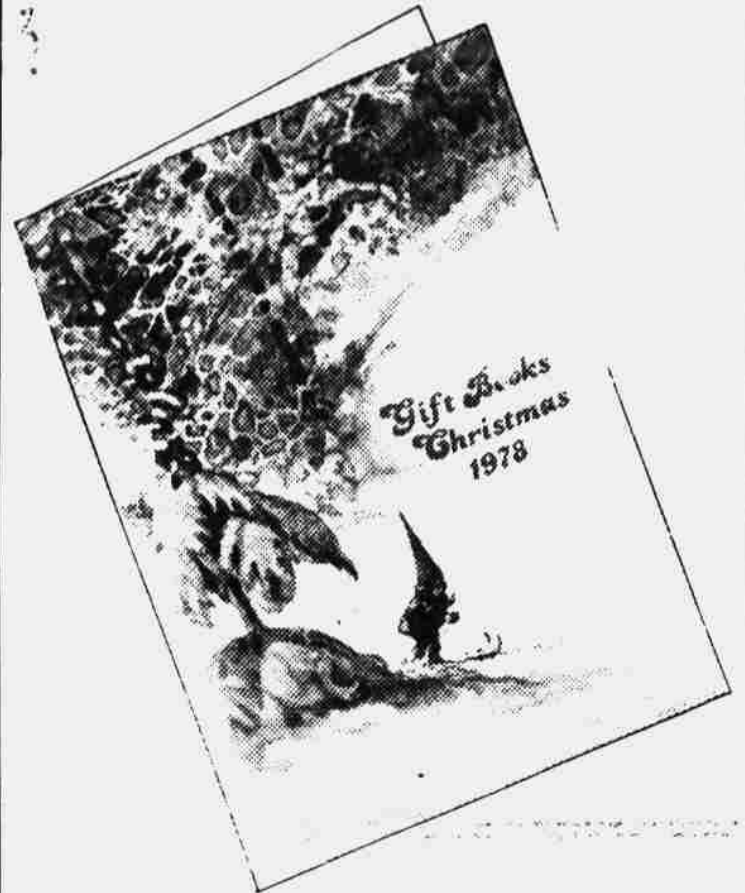
