## **Police Report**

A second-degree sexual assault and an attempted sexual assault were reported to the UNL police early Saturday morning.

The second-degree assault, which is under investigation by campus police, occurred in the Nebraska Union metered parking lot at 12:24 a.m. The victim said she walked through the lot and was knocked

down near a delivery truck. The victim described her assailant as a 19 or 20-year-old black male, approximately 6-1 or 6-2, weighing about 200 pounds with short hair. The victim said she kneed him in the groin and ran

to the Alpha Phi sorority house at 1531 S St.

several alternatives to the proposed acquisition, including a pro-posal to put Dodge Street underground and building a parking lot on top, and to stagger classes at UNO to ease the parking crunch.

The board also approved the hiring of a Lincoln architectural firm — Bahn, Vermeer and Haecker - to do the design work on remodeling projects at Architecture Hall and the Former Law building on the UNL campus.

Regent Robert G. Simmons of Scottsbluff objected to the hiring, saying the fee of 6.2 percent of the total project cost was too high, and that the architects had been chosen in a different manner than architects for other projects. Bahr, Vermeer and Haecker won a 1978 design contest sponsored by the regents, and was given the contract. Simmons urged renogotiation of the contract, but was voted down, 7-1.


