



"The inconsistency between stated intentions and achievement is . . . a direct consequence of complacently non-assertive posture which we as nants of a meal which others have eaten."

The suggestions of union opponents crystallize in a wait-and-see position that is clearly inappropriate in the political situation outlined by Petr.

Being represented by a union is one way UNL teachers can fight conditions that have produced apathy and depression in various departments during these years of low funding. And that's something for students to cheer about.




