# NUdeal platform opposes alcohol, visitation policies

NUdeal candidates announced their plans to enter the ASUN election on both campuses in an attempt to reach out to more

The clinking sound of silverware mumbled conversation could be beard Friday evening in the East Union caleteria as Burke; Darrin Lindquist, first vice presidential candidate: and Darin Werkmeister, second vice presidential candidate; told students that NUdeal was trying to end under-representation of East Compus stodents;

Lindquist outlined the NUdeal platform, which includes measures to make ASUN more representative of students by including senate sears for undeclared students, minorities and foreign students. The platform also called for representatives from the Interfraternity Council, Panhellenic and Residence Hali Association to be allowed senate

The Nebraska Educational Telecommunications Commission has formally backed a proposal that would allow the Nebraska ETV Network to acquire KUCV-FM public radio, an NETV official confirmed Friday.

Jack McBride, NETV general manager, said that the NETC, which along with NU licenses NETV, has advanced the acquisition proposal to the KUCV Board of Directors.

Under the plan, KUCV would serve as the flagship station of a statewide radio network. In 1985, the Nebraska Legislature passed a resolution allowing the NETC to establish such a network. No state funding was appropriated, however.

although it will be a tough goal to reach, Lindquist said:

"We feel that atudents of age should be allowed to drink single containers of alcohol where they live," Lindquist said. "Outside of their house or darm rooms, an opencontainer law would upply which would be almilar to open-container laws that apply for cars."

Lindquist said even if NUdeal's alcohol policy isn't implemented, they can make this goal more realistic in following years.

In their platform, NUdeal supported a student regent vote, elected student advisory boards for the engineering and journaliam colleges, orientation programs for foreign and transfer students, and power for residence-hall floors to determine their own visitation hours.

NUdeal's platform also stated that candidates will be active in the downtown-renovation project and will work against videotaped classes. But issues on a platform are not the only reason to vote, Burke said.

"The point is that anyone can write a platform," Burke said. "And we're especially proud of ours. This year, though, look beyond the issues and focus on the type of leadership this university needs to start it back on the path of excellence."

that the station become independent after June 30.

Earlier this month, a 38-member board was formed to decide what course the station will take after it becomes independent.

Robert Nefsky, president of Lincoln Fine Arts Radio, Inc., the board considering KUCV's future, said that no formal decision has been made on NETC's offer.

"With independence the risks and burdens lie totally with the community," Nefsky said. "On the other hand, we lose our independence, but maybe there's a greater possibility it will be funded."
