"Wilhite's knee is in great shape, and his recovery is really exceptional, considering other kids have taken two years to come back from similar injuries," Darlington said.

Darlington said he had also been pleased with the examples and leadership set by Wilhite, Heins and senior strong safety Steve Carmer.

"We have gotten tremendous lead-ership from Kenny along with Mike Heins that has allowed the younger kids to improve more quickly," he








