"I felt how the parents were feel-ing, and the boyfriend," Mortenson said. "I was disgusted."

Some students said the reality of such violence occurring in Lincoln was unsettling.

English major, said she thought the whole community was relieved but discouraged.

"It's really scary," Jabs said. "You wouldn't think things would happen like this in Lincoln.

Harms' body was found after one of two suspects arrested for armed robbery told police that he and a friend had abducted and kidnapped Harms the night of her disappearance.

Kim Stock, a sophomore psychology major, said she expected to hear that Harms had been found.

"I was glad they found her (but) upset she wasn't alive," she said.

Lancaster County Sheriff Tom Casady said Harms' body was found about 50 yards west of 134th Street and 800 feet south of Yankee Hill

Harms' body had been buried in a shallow grave, but was partially exposed, probably because snow and rain washed away the earth that covered it, Lacey said.




