investigated for their possible involvement in at least seven other robberies in Lincoln dating back to late August.

The two were charged on Dec. 4 with the Sept. 16 robbery of Rex TV and Appliance and the Sept. 30 robbery of the Goodyear Credit Union.

Each suspect was charged with two counts of robbery, two counts of use of a weapon to commit a felony and two counts of theft by receiving stolen property.

Both men had previous offenses, ranging from minor traffic violations to burglary charges.

Filing of charges was delayed as a result of the amount of paperwork involved in the case, which might involve the death penalty, Lacey said.

He would not comment on whether investigators had located the weapon involved in the incident, nor would he specify what evidence police had recovered from Pawnee Lake, west of Lincoln.

alumni and community members in their efforts to keep formal prayer on the commencement program.

Regents Chairman John Payne of Kearney, who has served on the board since 1981, said he had never received a complaint about the prayers.

But UNL Chancellor Graham Spanier said he had received a complaint as recently as Friday evening from a student who would not attend commencement if formal prayers were included.

Spanier, who emphasized that he was not taking an official position on the prayer question, said many students of non-Judeo-Christian backgrounds would be reluctant to make an open complaint about invocations and benedictions.

Spanier said he also thought it was unwise to pass resolutions that would undermine considered decisions made by campus committees.

UNK Chancellor William Nester said the elimination of the prayers at his campus last summer had not created a stir. The issue did not emerge as important until recently when UNL started to explore it, he said.

After the vote, Royce Ballinger, president of the UNL Academic Senate, called the prayer resolution a "God, motherhood and apple pie" resolution, and told the regents he understood how difficult it would have been for them not to approve it.

He said although he and other faculty leaders opposed the resolution, it would be difficult for them to ignore it because to do so would create a perception of faculty disrespect for the board and the wishes of the majority culture.
