Tussing said the Lancaster County board had no Nebraska precedent to consult when Shakers was preparing to open. In the past two months, she said, the board has examined what could be done if another juice bar wanted to open.

'We're kind of doing this after the fact, because there has been some concern out there," Tussing said. "I would try to do this ahead of time and have guidelines in place."

## **Obscenity laws**

Shortly after Shakers opened, Lincoln and Omaha residents wrote letters to the editor criticizing the state indecency laws.



nographic magazines also can be sold to those 18 and older.

State law prohibits the performers from touching customers. Dancers stand about 2 feet from Shakers' patrons. For an additional \$10, the women will perform a "couch dance" in a private room under the eyes of a bouncer.

The dancers, owners and customers are under the watch of the sheriff's department. Uniformed officers often walk through the building until its 2 a.m. closing. Wagner recalls the first two months

of the juice bar when his deputies were called to the establishment a few times a week. He said he was thankful the calls have subsided and the nude dancing hasn't brought a rash of problems.

However, he said, without a method to regulate the nude bar, a conflict will likely remain between the business and the community. That clash can probably be solved only by the legislature.

"I think there needs to be real clear ground rules that says what is acceptable and what isn't," Wagner said. "If the people of Nebraska do not want totally nude dancing, we need to articulate this."
