Meter maids on trial for heinous crimes

THE HAGUE — NUL Director of No-Parking Services, Tub McTowell and 26 members of his secret parking police sat silent Sunday as charges were formally filed against them in The Hague, The Netherlands.

"I have people EVERYWHERE!!!" he screamed. "You can run, but you cannot hide. And if I have my way, you will not drive either!"

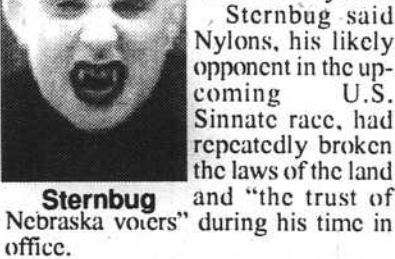
The trial is expected to last forever, or as long as students can afford to attend NUL.
