Supports	4/16/1998	Says he will sign the "lid" petition. (KPTM/Omaha World Herald debate)
Waffles	6/12/1998	Says the lid "will not be decided by the candidates, but by the voters." (Lincoln Journal Star)
	6/29/1998	Won't say whether he will vote for the lid. (Lincoln Journal Star, morning edition)
Supports	6/29/1998	Reaffirmed his full support for the lid. (Omaha World Herald, afternoon edition)
	6/30/1998	Says, "I'm so on the record. I don't want any indication that I'm equivocating." (Lincoln Journal Star)
	6/30/1998	Says, "Hello Bill. Over a hundred thousand people have signed those petitions." (Lincoln Journal Star)
	7/2/1998	Signed the lid petition.
	7/3/1998	Says he will vote for the lid. (KKAR)
Opposes???	7/5/1998	Reverses his position, deciding to vote against the lid. (Omaha World Herald 7/8/98)
	10/20/1998	University Regent Drew Miller says Mike Johanns says in private he supports the lid. (KFAB)
