Prof. I. M. Hodgman officiated as one of the judges at the state declamatory contest held at Fremont last week. A large body of teachers from different parts of the state were present. Professor Bigelow of Falls City brought up a contestant who was a very close second.

ATHLETIC BOARD MEETING.

At a meeting of the Athletic board held Monday afternoon the following intercollegiate rules were adopted. These are the same rules adopted last fall by Wisconsin, Minnesota, Michigan, Northwestern, Chicago and others.

1. No one shall participate in any intercollegiate game or athletic sport unless he be a bona fide student doing full work in a regular or special course, as defined in the curriculum of his college; and no person who has participated in any intercollegiate game as a member of any college team shall be permitted to participate in any game as a member of another college team until he has been a matriculant in such college under the above conditions for a period of one year or has obtained a college academic degree.

2. No person shall be admitted to any intercollegiate contest who has received any gift, remuneration or pay for his services on the college team.

3. No student shall play upon the team of any other college or colleges for more than four years in aggregate unless he shall have secured a degree, in which case he may play two additional years, provided he be a candidate for a second degree.

4. No student shall participate in any intercollegiate contest who has ever used or is using his knowledge of athletics or his athletic skill for gain. This rule shall be operative after October, 1896. No person who receives any compensation from the university for services rendered by way of regular instruction shall be allowed to play on any team. This rule shall take effect December 1, 1896.

5. No student shall play in any game under an assumed name.

6. No student shall be permitted to participate in any intercollegiate contest who is found by the faculty to be delinquent in his studies.

7. All intercollegiate games shall be played on grounds either owned or under the immediate control of one or both of the colleges participating in the con-

test, and all intercollegiate games shall be played under student or college management, and not under the control of any corporation or association or private individual.

8. The elections of managers and captains of teams in each college shall be subject to the approval of its committee on athletics.

9. College football teams shall play only with teams representing educational institutions.

10. Before every intercollegiate contest the respective chairmen of the athletic committees of the institutions concerned shall submit to each other a certified list of players, eligible under the rules adopted, to participate in said contest. It shall be the duty of the captains of the respective teams to exclude all players from the contest save those so certified.

11. Athletic committees shall require each candidate for a team to represent the university in intercollegiate contests to subscribe to a statement that he is eligible under the letter and spirit of the rules adopted.

12. No person having been a member of any college athletic team during any year, and having been in attendance less than one college half-year, shall be permitted to play in any intercollegiate contest thereafter until he shall have been in attendance six consecutive months.

Professor Hodgman will deliver the commencement address at Neligh high school on the subject "A Modern University Movement."

Thursday afternoon the freshmen football team got together for a few minutes and elected Griffith captain of the team for next season.

Last Friday the freshmen elected officers as follows: R. D. Anderson, president; Austin Collett vice-president; Miss Louisa Stratton secretary; Miss Hamilton treasurer, H. H. More historian; and A. S. Pearce the retiring president, sergeant at arms.

After a week's worry and indecision, it has been decided that the cadets will not go to camp this year. Milford was the place determined upon.
