Strength in Poetry.

Those who study James Whitcomb Riley's poems,-and there are thousands,-recognize in them a merit deep and lasting. His works have even more than beauty; hidden in the homely garb of rustic speech are words wise as Socrates uttered. His Hoosier dialect holds the wealth of Plato's wisdom, and philosophy as profound as Herbert Spencer's, and much more comforting. The dialect poem, 'My Philosophy' is the essence of many volumes of sermons. 'Beautiful Hands' and 'Illeles' suggest and equal Tennyson's 'Maud' in thought and passion. 'In the Dark,' 'The Lost Kiss' and 'A Vision of Summer' are Longfellow almost beyond his best. Scattered here and there are many passages worthy of Wordsworth.
