VALIANT VETERANS.

They Arrange for a Rousing Reunion Here in September. As has already been announced Council Bluffs has been fixed upon as the place for holding the next reunion of the Veterans' Association of southwest Iowa and northwest Missouri.

Yesterday afternoon there was a gathering at the Oden house to form the arrangements for the reunion. There were present A. J. Chantry, of Malven, president of the civil organization; E. Krotzner, of Coburg, Iowa, secretary; George H. Castle, of Shenandoah, Iowa, trustee; J. H. Booth, of Griswold, Iowa, trustee; E. F. Holmes, of Council Bluffs, vice president; and E. J. Abbott, of Council Bluffs, adjutant.

There were several sites for the encampment talked about, one being Pulmer's grove, another Fairmount park and still another, the driving park. It was finally decided to leave the matter in the hands of the committee, consisting of Col. Sapp, Major Lyman and Col. Kelley.

The details of reception were left to the field and staff. A committee, consisting of Col. Castle and E. J. Abbott, was appointed to prepare an address and various literature to inform the veterans as to the details of preparation and instructions as to how to organize and what to do.

J. T. Baldwin was added to the committee on transportation, which consisted before of Col. Sapp only. The secretary was instructed to secure, if possible, the attendance of General John A. Logan at the reunion as one of the orators.

The details were then discussed, but not decided upon as to the programme, except that there would be guard mounting and dress parade, daily company and battalion drills, and other similar features of interest, not only to the military, but also to the public. The government is to furnish 600 tents, and it is the purpose also to have arms furnished. There will be much fun in store also, and everything points to a merry time to all concerned.

The reunion at Shenandoah last year brought about 1,800 into camp, and as the territory has been increased since then and other organizations been included, it is safe to predict that there will be 2,500 veterans present at the reunion here. There will be as many more visitors, so that there will be doubtless come to this city over 5,000 people, drawn here by the reunion. In view of the magnitude of the event the citizens here will with one accord cheerfully give what help is needed to make the occasion an enjoyable success in all respects.

The following is the address prepared yesterday and which THE BEE is requested to publish: ATTENTION, OLD SOLDIERS, Comrades of Southwest Iowa and Northwest Missouri: The time for holding the annual reunion of the veterans' association of southwest Iowa and northwest Missouri is approaching. The coming reunion will be held in the city of Council Bluffs, Iowa, commencing on the 28th day of September of September, 1882, and will continue three days. The outlook is propitious for holding the largest and most enthusiastic reunion yet held by the association. All organizations attending former reunions are cordially invited to attend and localities not represented in former years are urged to organize and meet with us. Pleasant camp ground will be selected, and tents furnished. Daily programme of each day's exercises will be made out by the commandant. All old soldiers and sailors of the federal army and navy, who have been honorably discharged, are invited to attach themselves to some organization, and meet with us. Blank muster rolls will be furnished upon application to Comrade E. J. Abbott, of Council Bluffs, adjutant. The reunion of the 29th Iowa regiment will be held at the same time and place and will be an important feature of the occasion.

A FAIR OUTLOOK.

The Progress Being Made in Improving the Driving Park. Everybody and everything has a lively appearance in and about the driving park, the preparations for the coming fair and meeting, which is to begin Sept. 18, are being pushed along lively. The new building looms up in fine proportions, it being in the shape of a cross, each transverse being 45 feet in width by 150 in length, while from the center is being reared the tower 85 feet in height. The street on the east which has been given to the association in consideration of the city receiving another one still further east is being inclosed and being made part of the grounds thus giving this much more room. The grounds now embrace about 80 acres.

The lumber is on hand for the building of about 400 cattle sheds. Then there are already several large stables, and other convenient and spacious buildings. The improvements already made and in progress will render the associations grounds as nearly perfect as any which can be found. The mile track has already gained the reputation of being one of the best in the land, and inside this is a half mile track, which is being put in a most excellent condition.
