

COAL MINE CAL MITY.

Over 150 Lives Lost in a Virginia Coal Mine-Heartrending Details,

OVER A HUNDRED MEN KILLED.

Lyncheurg, Va., March 13 .- A special rom Pocahontas this morning says: An explosion occurred in the coal mines here last night at 12:3 and from 120 to 150 miners were killed.

1 p. m. -No further particulars yet reeived of the explosion in the mines at Pocahontas, Va. Great confusion prevails there, and accurate information cannot be had before evening. A special train with surgeons on board left this city orr the scene of the explosion at 10:15 this morning.

THE SICKENING DETAILS. PETERSBURG, Va., March 13.-Intellience just received confirms the story of terrible explosion in the coal mines of he Southwest Virginia amprovement ompany, at Pocahontas, Tazewell couny, this state. It occurred at 1 o'clock ais morning Particulars are very meagre, nothing has been learned as to how it occurred. Over one hundred men are known to be killed. These mines are owned by a joint stock company com-posed mostly of northern capitalists. Further intelligence from Porthontas represents the work of destruction at the

HORRIBLE AND COMPLETE. There were one hundred and fifty men in the mine at the time of the explosion, and not one is believed to have escaped. Phose not killed outright by the terrible explosion have most likely perished from after-damp. The cause of the explosion is not yet definitely ascertained, as the entries to the mine are all full of bad air, but the presumption is that one of the miners struck a fissure of gas. Several parties ventured into the mines this morning, but could not stand the at-

A NUMBER OF BODIES were discovered horribly mangled, some trunks, others with limbs all gone, pre-senting an appalling spectacle. The senting an appalling spectacle. work of destruction is not confined en tirely to the interior of the mines, but several instances entirely demolished.

TAKING OUT THE DEAD. The large ventilator of the Southwest Improvement company was blown to atoms, and the mines cannot be entered until another is constructed for the pursuffocating fumes. This work is now engaged in perfecting arrangements for the interment of the dead miners, most of whom were foreigners.

The latest intelligence is that an exploring party that entered the mines a short distance brought out six bodies in a frightfully mutilated condition. There is no hope that any will be rescued alive.

Ever since there have been ministerial relations the relations of the two countries have been satisfactory. After the war with Austria in 1866, and again after the Franco Prussian war, America gave numerous proofs of sympathy, not only with the prosperity of the empire, but also with the person of the chancel or. Nothing has occurred to disturb these good relations. From the outset I re-
