A QUARTETTE OF CASES.

The U. S. R. I. seeks to Enjoin Four Counties From Collecting Their Taxes.

The final act of the long litigated principle involving the taxes levied by the state and county authorities upon lands owned by the Union Pacific railroad in Nebraska was taken by that corporation yesterday in the U. S. Circuit Court.

Four suits were instituted by that company against the counties of Platte, Colfax, Gosper and Hall, and their commissioners and treasurers. The petitions set up the incorporation of the plaintiff under the act of congress and the subsidy of each alternate section of a strip of land twenty miles in width lying on each side of the track.

The plaintiff alleges that when the above taxes were levied no patents had been issued by the government to these lands, nor had the costs of surveying, selecting and conveying been paid, nor had the register or receiver at the land offices received their fees for entering them upon the books of their offices.

The plaintiff attempts to bring its case under that decision of the United States supreme court which decided lands not taxable until a patent to them had been issued by the government.
