

THE DEADLY ELEVATOR.

Chicago Times, Ill. There was a sad accident yesterday at the Lealand hotel, in which one man lost his life and another received injuries from which he is expected to recover. At about 4 o'clock in the afternoon, a couple of employees of the house, named William Foster and John McKillop, had orders to move a heavy wardrobe from the first to the sixth floor. Upon their own responsibility they took it to the freight elevator, and the cage being too small to receive it, they put it on top, getting into the cage themselves, and started up. They evidently forgot the extra weight on top of the cage, and the heavy furniture crashed into the beams of the roof from which the tackle was suspended. The powerful engine kept at its work, and with a wrench the two steel wire cables—each three quarters of an inch in diameter—were cut by the drum. There were two barrels of terror, and the heavy machine with its human freight shot down almost like a lightning flash to the basement, a distance of about twenty feet, where it lay, shipwrecked. The men were quickly extracted and were both faintly moaning, though unconscious. They were taken to the county hospital, where John McKillop died in a few hours after his arrival. He was an Irishman, about 24 years old, unmarried, and had been in the country only about one month. His injuries were internal and extensive of the brain. Foster, who had been working on the right leg besides other injuries, from which he is not likely to recover. He is 25 years old, unmarried, an Irishman, and had been in this country about a year. Mr. Leland stated that the elevator was one of the make of O's Tuffs, had been recently overhauled, and that it had been running for some time. It was evidently due to the carelessness of the men in not stopping before they reached the top floor. Why Dairying is Profitable.

Philadelphia Record. The dairy farmer, as a rule, is prosperous and has fewer drawbacks and better results than the farmer who makes a specialty of grain crops, or even general stock raising. The dairy farmer is not so much dependent on the farmer to sell his crops in the shape of manufactured product, thereby securing better prices than when the crops are marketed in bulk. The majority of dairymen, however, have not realized the fact that they do not derive more than one-half the milk from their cows that they should receive. There is a disposition to be satisfied with a small quantity of milk, and to wonder why the great or small. While we have in this country breeds of cattle that are superior for milk production, and individual animals from such giving of from 20 to 30 quarts daily, the average quantity of milk derived at the dairies is less than ten quarts. And yet with this small quantity from each cow dairying proves profitable, and will continue to be so, the reason why the profits should not be greater.

Dairying does not pay simply because the cows give milk but because there are several matters connected with dairying, which, as a whole, renders the business one that adds permanently to the wealth of the farmer and increases his capital in a manner not always observed. The cows not only furnish the milk, which produces larger crops of food and adds to the number of the animals that can be sustained. In other words, dairying is a system that tends to improve the soil, and to increase the fertility of the land. It is not admitted, however, that in the course of time the elements of fertility will pass away in the milk, and young stock sold on the farm, but that the fertility of the land is not so much diminished as is generally supposed. The reason why dairying is profitable is because the farmer not only keeps up the fertility of the soil by the use of stock, but also by the better prices obtained for his products, as compared with the general farmer, which gives him a surplus and enables him to expend a proportion annually for food to be brought on the farm.

If dairying, however, is profitable with the above conditions, it is not profitable if the milk daily from each cow and the estimate is high, it cannot be denied that the profit could be increased if better animals were used. As long, however, as farms are so small as to employ but few cows, it is not profitable to purchase high priced animals, but to depend upon purchasing fresh cows whenever the milkers become dry. The practice of purchasing fresh cows with any regularity, and to depend upon the value of such cows until they have been tested, which may show many of them to be worthless. Every farmer can do this with very little risk. The quality of milk a day, but every farmer can, by the use of thoroughbred bulls of the Holstein or Ayrshire breeds, so grade up his herd as to double the profit. A good cow requires no more room than an inferior one, nor is the labor and care necessary in the management greater. The expense of feeding will be little more, while the profits will be much greater in proportion to capital invested. With the desire to improve comes the inclination of adopting better systems of management, and in dairying this is especially true. Areas for pasture, and larger fields for cultivation, as well as the careful saving of the manure, and the selection of the choicest and best animals every season, will pay for themselves. The management of the product (milk) will be so conducted as to improve the quality of the butter, thereby adding to the profit by increased prices as well as from the extra profit resulting from improvement of the stock.
