Republican Candidates Address an Enthusiastic Meeting at the Annex.

AN EXPOSITION OF PRINCIPLES.

Addresses Delivered by E. Rosewater, E. W. Simeral, W. G. Whitmore. Dr. Ricketts, John Mathieson and James Young.

The Republican Rally.

The annex of the exposition building was packed last night by an andience that gathered to hear the political issues of the day discussed by the candidates of the republican party. It was an interesting audience. There was a complete and pleasing absence of listless hearers, of men who had gathered for the purpose of amusement, or for passing an idle hour in a comfortable hall. The audience was composed of voters who had assembled for the purpose of hearing the candidates upon the republican legislative ticket state their positions questions that are of such vital interest and importance to the people of Douglas county and the state at large. At 8:39 o'clock Mr. J. B. Southard called the meeting to order. On motion of Judge Stenberg, Senator Alvin Saunders was named chairman of the meeting. As the venerable and honored representative of Nebraska republicanism walked to the platform the cheers of the assembled audience greeted

cheers of the assembled audience greeted him. Taking the platform, Senator Saunders said:

Gentlemen of the meeting: I have been bonored above anything that I expected. I came here to night to hear; of course this will not prevent me from hearing. I do not know exactly the programme, and have been busy and been in the country, and remembering that there was to be a republican meeting to-night, although I have not taken a very active part in the canvass, I have no objection to serving you in the capacity to which you I am a republican and helped organize the republican party in the northwest, and from that day to this I have considered myself to be a member of it and want to be considered a good one. I think a great deal of the republican party. The fact is that no party since the government was started has ever done half so much for this country as the republican party has done. Aside from the republican party has done. Aside from all that was done in the war, about which you all know, and which will be told to you by the speakers here to-night—what was done in freeing the slaves and all that kind of thing—it has done more to give credit to our people at home and abroad, to give good wages to the laboring man and business to wages to the laboring man and business to them than any other party ever did since the country was organized. (Applause.) Then why should not I be proud of it? Some of you may think that I am not a laboring man, but I think, if I understand myself, since I came out of the senate I never worked harder. Without detaining you, and without knowing how many speakers or whom I will call the meeting to order and ask for your further pleasure. (Applause.)

MR. E. ROSEWATER.

Calls were made for Mr. Rosewater, candidate for float senator, who responded and addressed the meeting at length. The following is a liberal synopsis of his

remarks: Mr. Chairman and Fellow, Citizens of Mr. Chairman and Fellow; Citizens of Douglas county:—Many of you have come here to-night with the idea that General Van Wyck would address you. I regret very much that you are to be disappointed, but you will not be if you will be here next Monday night, when he will address you in this building, probably in the main building, because this annex is hardly fitted for a large

I will not attempt to discuss the national Issues—they were ably discussed here Thurs day night by the republican candi-date for governor, General Thayer, 1 date for governor, General Thayer, I will not discuss the congressional issue. I think that has been very thoroughly discussed in the newspapers. [Laughter]. But I will say a few words with regard to matters that concern Douglas county and particularly Omaha in the coming legis-

First and foremost, perhaps, this city is vitally interested in the revision of the charter, and in remodeling the laws regulating the municipal government, so as to enable us to conduct that covernment, more economically and more efficiently than it can be conducted under the present charter. You all know, doubtless, that great com-plaint has been made in this city about the police and yet we all know that under the present system it is utterly impossible to have an efficient police. We want a police commis-sion, and we want what they call a metropol-ltan police. We want many expensive public Itan police. We want many expensive public improvements that under our present system of assessment cannot be had. We have this year added—I don't know how many additions—perhaps twenty or thirty additions to Omaha. [Governor Saunders: "No, we can beat that."] All these additions and the environments of this city are now deriving the benefits of the city government—they derive the benefit of waterworks, police, fire department, etc., and yet they contribute nothpartment, etc., and yet they contribute nothing to the expense of these departments. We must in some way incorporate a portion of these additions within the limits of the city, or place them where they will contribute their share of city taxes. In order that we may get our charter amended, however, as it now transfer we will be at the contribute from the contribute of t share of city taxes. In order that we may get our charter amended, however as it now stands, we will have to get permission from Lancaster county, or rather from the city of Lincoln. Up to this year Omaba has at all times had a charter distinctively her own. One of the editorial fraternity of this city—the late E. B. Taylor, was once elected to the state senate, and in that capacity he drafted and brought to its passage the first charter giving Omaha the fitle of a city of the first class. That charter has been amended and re-amended every two years. So that with the charter as it now reads, any city that has a population of 30,000 or more is enabled to operate under it. The people of Lincoln this summer, by a great strain on the part of its municipal government, have taken a census of their own, irregular though it is, which has been filed with the governor and he has recognized it as a city of over 30,000, therefore being entitled to be one of the cities of the first class. Now then, fellow citizens, if I should decide to wear Governor Saunders' suitcide to wear Governor Saunders' suit-you would think I would have to alter it some. When Lincoln puts on one of our suits, it will be a lit-tle loose won't it? She proposes to go to the next legislature and draw in some of the

the next legislature and draw in some of the seams.

We have been having a very expensive government for a city of \$0,000 people, but not for a city of \$0,000. There will be the conflict. The interest of Lincoln will be to take this charter and reduce, if possible, all the departments to the dimensions of a city such as Lincoln is to-day, and our effort will be to expand it, if possible, for a city of 100,000 to 150,000 people. The question that presents itself to every citizen here is, Ilow are you going to do it? And I must say that I have laid awake nights thinking of this matter, until an idea has struck me which, in my opinion, will solve that problem. If elected, I propose to go to Lincoln and assist my colleagues in drawing up a charter in the following fashion:

ing fashion:

AN ACT incorporating metropolitan cities in the state of Nebraska.

Be it enacted, etc., that whenever any city in this state shall contain a population of 60,000 or more inhabitants, according to the returns of the national or state census, it shall be known as a metropolitan city and be governed by this act."

The speaker then at some length discussed the importance of the reapportionment of the legislative and judicial districts that must be made next winter. At present, Douglas, Sarpy, Washington and Burt counties have two judges. The legislature will probably ereate Douglas county one district with two fudges, while the other counties of the present district will have one or more judges of their own. We may, if it is deemed advisable, create additional municipal criminal courte for Omaha, to try cases that cannot be disposed of by the police court.

"Another important problem which the next legislature will be called upon to solve fs, what are we going to do with the penitentiar?" Although the contract under which that institution is now conducted will not expire for two years, the pent of the provision for a change that will make it self-supporting.

I have not time to solve. With reference to convict labor, however, I will say that in my opinion the penitentiary can be made self-sustaining instead of an expense to the state of \$130 every day of the year. Down in Arkansas each convict by his labor is made promable to the state. They have a state farm and the prisoners are required to till it. Nebraska could do likewise, and instead of paying 40 cents per day for the maintenance of each convict, he could be made to dig enough out of the soil to board himself and pay for his own clothing at lenst. Boss Stout has a farm now which he is working by convict labor and the state penitentiary farm would be just as safe for the class of convicts who have committed folonies punishable by from one to five year's imprisonment. This class includes seven-cighths of all the convicts. The murderers and dangerous convicts could be employed at hard labor.

employed at hard labor.

There is no competition to fear from convict labor on a farm. The price of grain, pork and beef is not regulated by home competition but by the Liverpool market. The convict farmer would no more interfere with the grain producess than the machinery on his farm. The management of our penitentiary has been very loose and needs thorough overhauling. Some of the men in charge of convicts are it subjects for wearing the employed at hard labor. of convicts are fit subjects for wearing the

Douglas county is interested in the state institutions at Lincoln, as she has paid one-tenth of their cost, and is taxed very heavily for their maintenance. The Lincoln ring-leaders charge that I will attempt to raze the whole city if elected to the legislature, and yet I have done more to advertise the growth and prosperity of that city than any man or paper in the place. The papers there have continually standered, reviled and lampooned Omalia, while our papers have always reated that city fairly. When he was a candidate for the senate no Omaha paper called for his defeat, and if it had done so the people of Lincoln would have resented it. The great mass of the citizens of Lincoln are reputable, but their papers never allow a day to pass without assailing Omaha, when in fact they ought to know that this community cares no more for their barking than they would for Bellevue or Council Bluffs. I only need to cite a recent instance of meanness on the part of the Lincoln press. St. Joe held an exposition, Kansas City held St. Joe held an exposition. Kansas City held one, and they were praised to the skies, but the Omaha exposition was a subject of the most bitter comment. Omaha has as much right to an exposition as Kansas City or St.
Joe, but enterprise in our own state is condemned, while that in Missouri cities is commended. This is not the meanest part of
it. After the Omaha exposition had closed
Lincoln papers advertised far and wide that
our hotels and storkleapers robbed and our hotels and storekeepers robbed and cheated everybody that attended the exposi-tion, and even imported thirty or forty pickpockets for the fair grounds to despoil the visitors from abroad. When Omaha adver-tised fast horses on the race track, Lincoln papers announced that the races would not come off and the horses would not trot in Omaha. Could anything be more contempti-ble? Some years ago the Lincoln boodlers passed the hat around for a Douglas county passed the nat around for a Douglas county candidate for the state senate whom they were anxious to float. Now I am told that they are passing around the hat to defeat a candidate in Douglas county. You can form your own conclusions about that. A gentleman who has interests in both cities is said to feel your tired abbout my candidate. man who has interests in both cities is said to feel very tired abbout my candidacy. Not four weeks ago. I, with eighty others, assembled in this building and voted to make that gentleman our choice for governor, and we kept our pledge. We voted for him once and were ready to vote again, had not General Thayer been nominated. It is strange the blame of his defeat is now laid at my door. Coming back from the convention I asked him who acted as his confidential manager, because I back from the convention I asked him who acted as his confidential manager, because I was surprised that the great boom I had expected from the drug stores in materialize, I Laughter.] He said it was Mr. John M. Thurston. Now, when Mr. Thurston runs for the state senate I hope he and his relatives will pay their attentions to him and not the me.

One of the questions propounded to me is. One of the questions propounded to me is, whether or no the architect of the city hall paid me for getting that contract. It is needless to say that he did not pay me a dime. I have had an interest in that hill for nearly twenty-three years. I own that much talked of lot, which I have not seen fit to sell because I intend to build on it. On that lot I had lived next to Governor Saunders for four years, but when my home was left twenty feet in the air I had to vacate. By my personal effort Farnam street was improved and leveled down. I collected \$7,650 from property owners and paid it over to the city treasury as a donation to cover damages. Of this amount I paid \$500. My damages. Of this amount 1 paid \$500. My young friend, whose inherited Farnam street property was more than doubled in value by my labor and at my expense, did not pay one dollar towards the improvement except taxes. I was no deadhead in this enterprise any more than I was in the Grand Central botel, to which I subscribed drand Central notel, to which I subscribed and paid \$1,250, while my enterprising friends of the Herald paid their subscription in Babcock extinguishers. Those extinguishers were extinguished when the hotel burned down, and so were my \$1,250.

The first will be the re-election of Senator Van Wyck, and with that end in view I propose, if elected, to keep my boots on seven days and seven nights as I did ten years ago when we elected Governor Saunders. [Applause.] During that contest some people thought I did not sleep a wink, but that is not true. If I go to Lincoln this winter I may sleep some, but nobody will catch me asleep if I can help it."

W. G. WHITMORE. At the close of Mr. Rosewater's address calls were made for different candidates on the republican ticket, Mr. Whitmore's name being the most frequently men-tioned. Mr. Whitmore responded and was introduced by the chairman as being the candidate chosen by the republicans to represent the farmers of Douglas county in the legislature. Mr. Whit-more's appearance was loudly applauded. After thanking the audience for calling

upon him he said: I acknowledge one distinction here to-night and that is I am the only nominee of either party for the legislature who was there at the last session, and as such it is natural and I think it is true, and I say this without any egotism, that I understand something about egotism, that I understand something about the needs of Douglas county and of Nebraska in legislative matters which other members may not understand as well.

Any man who is lit to go to the legislature and has his wits about him through a session cannot help but get some ideas in his head and I think I have got a few. I believe, gentleman, that if I am re-elected this fall as I expect to be that I will be of more service to Douglas county and the state of Nebraska in the next session of the legislature.

I believe that it is possible and ought to be that the penal institutions, noticeably the state prison of Nebraska, should be self supporting. There was a story started in less than a half an hour after I was nominated stating that I was a crank on that question, but they found when it came to the test in the legislature that I was not. I am on record as voting against that proposition, I did it from principle. I am a temperance man, never was drunk, and hope I never shall be. I do not think that it does much for any of us to get that way. But while that is true, I do believe that the present law upon that question is far preferable to any prohibition law that it would be possible to enact. (Applause.) I am nominated especially as a representative of the farmers of this county, and in that capacity I feel like saying to you that up to within two years ago the farmers of this county had come to look at Omaha a good deal as it you were going to have things politically your own way anyhow. And every nominee who has been put up as a sort of a compliment to the country voters had been knecked over, and I believe that I enjoy the distinction of being the first representative elected, or certainly in a long series of years. And the people in the west end of the country were gleased to learn, and they acknowledge it that you of Omaha who have the power to vote us up or down, you who have three-quarters of the votes in Douglas county, were disposed to deal fairly by us in the country when we give you candidates who deserve your support. We ask your support in this canvass, Of course it don't become me to say so, but my constituents in the country believe thap they have a candidate worthy of your supt ort or they would not have presented me. It is stated in the papers that I am making my canvass personally upon my record. I do

not mean to be egotistical about that, but I do say that while I am a candidate for re-election to-night I do not recollect a single vote of mine during the last session of the legislature that I would change to-night if I legislature that I would change to-night if I could. Gentlemen, I am not ashamed of my record. (Applause). I consider it a compliment that I am the only member of legislature of either party who is renominated. My vole upon all questions is in the interest of the people, in the interest of the producers and in the faterest of the workingmen. (Applause). It was in opposition to Boss Stout's schemes, in opposition to tricks and rings from first to last. That is a record I am willing to stand on, and I rathet expect and hope that it will result in a majority next Tuesday and if it does I shall not go back on that record. E. W. SIMERAL, ESO. The next speaker introduced was E . Simeral by the chairman who said: I now introduce to you a young man who has worked day and night ever since

"I now introduce to you a young man who has worked day and night ever since he has been here to try and make an honest living. He is a true republican and will now speak for himself, but you will have to do the voting next Tuesday for him." Mr. Simeral said:

Mr. Chairman and Fellow-Citizens: As Senator Saunders says I have been laboring for a long while and have been working so hard from the time I was nominated until the present that I have not had time to prepare an extemporaneous speech to deliver to you to-night. (Applause.) I have very little to say upon the question appertaining to the legislature as I am not running for that office. I sometimes wish I were, especially since Mr. Rosewater has been nominated because I know if I were on the legislative ticket and elected with him I would see lots of fundown in Lincoln next winter. I am certain that if the republican legislative ticket is elected they will serve the people of this county effectively, honestly and with ability. There is one vital question which the republican party of this county at least is square and solid upon, and that is anti-prohibition.
