A CUBAN GIRL'S HEROIC DEED. She Carries Food and Medicine to Fever-Stricken Prisoners.

I am a Cuban and I love Cuba, says Senor Remeariz in the Nashville American, yet the extreme heat of some months of each year is unbearable. You remember the entrance to Havana harbor is guarded by Morro castle. The garrison numbers 200 men. Three years ago last June the temperature rose be yond all previous records, and the suf-fering was intense. The authorities dreading the possible invasion of Cuba's deadliest scoarge—yellow-fever. News came to the city of the breaking out of the fever at the castle. Immedately steps were taken for the complete

low. I land from the infected locality were brave enough to venture the casting of their lot with the gar rison. At sunset each day we watched the gates open and funeral corteges wind their way down the hill to the little garrison cemetery; we listened for the volleys of salute, their number denoting how many brave fellows had succumbed One evening, as we apathetically gazed across the water, a boat shot forth from the pier of Havana. It was loaded to the gunwales with provisions and medicines, and none in that crowd needed to be told its destination. Our eyes then sought the guider of the little craft, and, to our horror saw the sole occupant was a woman. Then a universal shout of protest came-to late. She paused an instant from her rowing and silenced our murmurings with a wave of her small hand.

"I am alone," she said, "from all Havana not one regret will follow me. 'Tis better that I should go than a life upon whose tenure hangs the fate of others.

We strained our eyes across the water; watched her strokes grow slower and slower as the awful heat sapped her life and finally pause exhausted be-neath Castle Morro's walls. Those faithful souls, brave and constant to the last, refused admission, though we could feel the hunger and longing expressed in their long suffering eyes. At length faint resistance ceased—they eagerly came down to the welcome boat fairly lifted their angel of mercy on waiting shoulders and, followed by others bearing the medicine to which many poor fellows will owe their lives, were lost to our view within the castle The first effect we noted was the re-

duction in the number of salutes over the soldiers' graves: then one blessed morning, when a breeze all but c ol. came straight from your northland, the distress signal was hauled down, and again the royal flag of Spain floated proudly from the battlements denoting all was well within. Instantly the bay was dotted with boats. We flocked to the castle and exchanged congratulations with the governor and his badly decimated garrison. We learned that undoubtedly not a life would have been preserved had it not been for the brave maiden's timely succor. Now, there, gentlemen, is an incident of the land of

A Voudoo Queen.

There is an unprecedented sensation among the colored people in the black district, the cause of it being a woman who is working, it is alleged, marvelous faith cures in Nash county, says a Raleigh dispatch to the Atlanta Con-stitution. The woman is an African of the most pronounced type. A gentleman visited the ground consecrated to the priestess on conjurations and faith cures. He found the roads for hundreds of yards leading to the spot cumbered with vehicles of every conceivale character, all conveying the afflicted in body and mind. The woman receives her devotees and cries aloud, in a peculiarly deep voice, exorcising the evil spirits of disease, imaginary or real. Then she anoints them with water drawn from a well near by, at the same time requiring the patient to imbibe a portion. The spot, she claims, was pointed out to her by an angel. These seances have been going on for ten days. Each day brings a crowd greater than that of the day before. The woman fills bottles with water, blesses them, and these are carried off in countless numbers. She makes no charge, but accepts whatever may be

given her. Excitement runs high and is widespread. The multitudes that place implicit faith in the efficacy of her cures are astoundingly large and constantly swelling. The woman's name is Mary Edwards. She is about thirty-two years of ago. The gentleman who vis-ited her entered a double house, and found the front room crammed and jammed with all ages and sizes and both sexes. One at a time is added to the inner sanctuary.

The woman avers that she was born entirely white, and that the knowledge of her mysterious and marvellous powers came with her dawning reason. She has followed her present calling some time, and it is reported that she has taken in nearly \$1,000 in the four weeks she has been established at her present quarters. Persons from many countries visit and seek relief at her hands. Her white patients are not small in number.

Cheats in Every Trade. "There are cheats in every trade, said a florist recently to a Troy (N. Y.) Times reporter, "but in none are they more frequently met than in ours." The remark was caused by a lady who passed by, holding a bunch of roses in her hands. "Do you see that lady?" asked the flower man. "Well, she has just been cheated. She came in here an hour ago and asked our prices for Marechal Niel roses. I told her from \$1.50 to \$2 a dozen. She said she could buy them elsewhere for 85 cents, and walked out. Now, what has she bought? Simple Perie des Jardin roses, which are worth 50 cents a dozen. An ordinary observer cannot tell the difference between the two varieties. The Niel is a softer, richer yellow than the Perle, which has crisp, sharply-outlined leaves. The stem of the Perle is long, straight, stiff and thorny, and red and green are mixed together in blended lines. The stem of the Niel is small and tender is much smoother than the Perle. Another cheat is the making of bridal bouquets of orange blossoms. Not one bride in 500 who is described as wearing orange blossoms is so fortunate as to have them. An orange-flower wreath or bouquet would cost from \$15 to \$30; so the dealers take stephanetis blossoms, worth from \$3 to \$5, and array the unsuspecting maiden at a lesser price but greater profit. English violets are worth \$1.50 per hundred, and are used to make the letters in set designs. For these are substituted immortelles, colored purple, and worth 15 cents a hundred. I recently saw a "Gates ajar" made of immor-telles which cost probably 50 cents, when if the form had been filled with English violets the cost to the flerist of the flowers only would have been at least \$5."




