The Atchison and Burlington Reaching Out After St. Louis Traffic.

CHICAGO'S STARTLING DISCOVERY.

Rights of the Illinois Central in That City Under an Old Ordinance -The Sleeping Car Decision.

Curciso, Oct. 3 .- |Special Telegram to The Bee.] -Within a short time new routes will be opened between Chicago and St. Louis by the Atchison and Burlington roads. The Atchison system will never be complete until it has a St. Louis line in connection with its main lines between Chicago and Karsas City, President Manvelsaldyesterday: "I should not wonder if the St. Louis line from Chicago will be the next property the Atchison owns," but he would not say that this line was now under consideration. The reason was made plain today when it was learned that the Atchson had made a contract with the Jacksonville Southeastern by which it gained mileage r this over that line, and from which route it can by various lines run into St. Louis. This line is especially necessary for freight and passenger traffic in connection with the Atchison, St. Louis & San Francisco line, which now practically ends in the air as far asthrough traffic is concemed. The Atchison recently ordered the equipment for seven of the most elegant trains of Pullman car build and it is thought that the St. Louis lines will be opened up as

on as they are completed. The Burlington is the other bidder for the rich St Louis passenger traffic. It has been a standing wonder why the Burlington has not used its existing line for passenger traffic. and today General Passenger Agent Eustis

REED GOING ON THE STUMP.

The Speaker Will Deliver Campaign Addresses in Various States.

AND FOSTER HIS PRESIDENTIAL BOOM

The Registration Law of Maryland Will Cause Many Republican Citizens to Lose Their Right of Suffrage.

513 FOURTHENTS STREET, WASHINGTON D. C., Oct. 3. Speaker Reed has gone home for a few days to attend to some private business, but will take the stump next week and make what is intended to be a "triumphal tour" through the country in his own interest so a prosidential candidate. He will travel in a special car with a party of friends. The bands are expected to play "Hail to the Chief," and the people are expected to shout for the next president whenever he makes his appearance. He speaks first in Massachusetts, then in Connecticut, New York and Pennsylvania. Then he goes into McKinley's district in Ohio, where he will make two speeches. His next appearance will in Indiana, where he expects speak at Indianapolis. Then he goes over to Danville, Ill., to help Cannon, and from there to Chicago. He will speak once in Wisconsin, probably at Miswaukee, then in Iowa, and perhaps in Nebraska and Kansas, although the programme has not yet been arranged for that part of the country. Returning east, he will speak in Michigan and probably again in Pennsylvania, either at Pittsburg or Philadelphia.

MARYLAND'S REGISTRATION LAW. There is a curious situation in Maryland. The legislature of the state recently passed a registration law which disfranchises a large portion of her population, as it provides that o mm shall be a legal resident unless he sleeps within the limits of the state every might for six months before the November election. Therefore a citizen of Maryland, no matter what the reason may be for his temporary departure or how short his ab-sence, if he makes his abode and hab-itation for a single night outside of the state is in danger of losing his right of suffrage unless within thirty days after the passage of the act, which was approved in April last he make affidavit in person he in April last, he make affidavit in person be-fore the clerk of the circuit court that he was compelled to absent himself from his regular residence and intended to return. By this act Maryland has deprived of the right of suffrage all her sons who travel outside the limits of the state between May and November, who go to summer resorts, all who sleep one night in New York, Philadelphia or Washington, all her soldiers and sailors, all her appointees in the foreign service of the federal govern-ment and her senators and representatives as well. The object of this law was to disfran-chise the republican voters of Maryland who reside in the District of Columbia and hold office here, but the effect of it will be far-reaching, and a great many people will be surprised when they come to cast their bal-lots in November, for the law is as clear as possible on the points mentioned.

POSTOFFICE DEPARTMENT CHANGES. Postmaster General Wanamaker intends to make some important changes in the post-office department. He will abolish the office of superintendent of foreign mails and place that department directly under the control of the second assistant postumater general, Mr. J. Lowrey Bell, who has had the former ofministration and who has been promoted to the latter. Mr. Whitfield, who becomes first assistant postmaster general, will have command of the free delivery service in the same manner. These consolidations, Mr. Wanamaker thinks, will promote the efficiency of

REPUBLICAN CAMPAIGN LITERATURE. A remarkable line of campaign literature has been prepared by the republican con-gressional committee. These documents are short and attractive. They relate almost en-tirely to the issues that have been developed in this congress. One of the pamphlets is en titled, "Facts from the Treasury." This pamphlet shows how this administration has saved the people \$51,000,000 in its redemption of the bonded debt. Another is entitled. "Fair Elections or Foul—Choose," the significance of which is apparent. Another entitled, "Better Days for Farmers," relates to the effect of the McKinley bill upon all agricul-tural products and supplies, the silver bill, the pension bill and various other issues. These documents have been circulated by the million and a force of about one hundred men and women are employed night and day in sending them off. The scene presented by all this activity is unique and interesting. Speakers have also been engaged by the committee. THE BLOT OF MORMONISM.

Governor Thomas of Utah Discusses It in His Annual Report.

THE PEOPLE GOVERNED BY PRIESTS.

In All Political and Business Acts the Church Put First, the Country Afterward -Some Recommendations.

Washington, Oct. 3.-The Mormon ques

tion is discussed by Governor Thomas Utah in his annual report. He asserts that and that in every political and business act will lose a congressman in the church is put first, the country aftermated at 230,032, an increase of 55 per cent during the past ten years. Moreover, they declare that they made no demands upon the directors, but only suggested that it would be to the advantage of both sides if only union labor was employed in the works. BIG GUN OF THE CAMPAIGN,

Donglas Cout Republicans Fired it in This T Last Night.

AN ARRAY OF ELOQUENT SPEECHES.

Hon. L. D. Rich , John L. Webster, Edward Ros ter, W. F. Gurley and Ot Address a Monste ceting.

At 8:10 o'clock last evening Colonel Thomas Swote, chairman of the republican central committee of Douglas county, called to order a gathering of nearly fifteen hundred republican voters of the city and county.

The meeting was held in the Grand opera house, under the auspices of the Douglar county republican club, and was the first rally of any extent held in the city since the opening of the present campaign. Large delegations were present from every ward in the city, and South Omaha was well represented.

For a short time before the audience assembled, the Omaha Central colored band occupied a place in front of the building and discoursed inspiring strains,

The gathering was a representative one, being composed to a very large extent of prominent business and professional men. It was an audience that could not fail to favorably impress the republican candidates with the high character of the hearty support to be accorded to them in Douglas county. It was entirely free from the boodlum element that is but too often a characteristic of a po-

The reception accorded the candidate for governor was a warm and enthusiastic one and augurs well for the result of the campaign as showing the great interest felt in this county in the success of the republican ticket. Mr. Richards could not conceal the pleasure he felt at the hearty expressions of cordiality and support.

When the speakers of the evening stepped upon the stage they were greeted with rounds of hearty applause, and much interest and enthusiasm was manifested.

The body of the house was well filled when Colonel Swebe, in a few well chosen words, introduced the republican candidate for governor of Nebraska, Hon. L. D. Richards of Fremont. Mr. Richards said:

"It gives me great pleasure to meet with the citizens of Omaha tonight. I have many warm personal friends among your people, growing out of many years of business rela-tion with them."

The speaker then referred to his home city,

Fremont, helping to build up the industries of Omaha, attracted by the superior advantages of the city as a great commercial me tropolis of 140,000 souls, with business interests the magnitude of which compels the wonder and admiration of the people of the wonder and admiration of the people of the east, and whose future prospects are unequated by any city west of Chicago. He said some people were making an attempt to convince the community that he had a personal projudice against this city. This he denied as a whole, and showed that it has been a campaign rumor. He said:

"If I am elected I shall perform the duties of the office to the best of my ability and take pleasure in serving the best interests of the people of Omaha. I have been a republican in the ranks since 1868, casting my first vote for that great captain, U. S. Grant. I believe honestly and thoroughly in the fundamental principles of the republican party, and that its continuation in power means honest gov-ernment, the righting of wrongs and the cor-

rection of abuses where they exist.

"The national congress is carrying out the pledges made to the people in 1888, viz, the molification of the tariff with the reciprocity idea as advocated by our great commoner, James G. The credit of the state has been good—too good and the ease with which money has been obtained has involved many in debts that con-servatism would have avoided, but notwithstanding this, the state has managed to keep

ace with rival communities.
