The falling off in the valuation of Precinct 10 of the county as compared with the former assessment of the precinct of East Omaha has been taken from its territory. The decrease in the Eighth ward is a matter that is not unusual.

South Omaha's decrease is caused to some extent by the fact that it has lost one section of land that has been taken to be located in Precinct 10, and also that out of the former precinct of South Omaha the precinct of "Clarendon" has been created. The falling off in the valuation of Precinct 10 is due to the fact that many of the lots in that precinct have been taken for other purposes.
