Cornelson against Matthias Kuhl, Gertrude Kuhl and J. B. Sweet, in which the plaintiffs have made application for the appointment of a receiver for the property of Mrs. Kuhl. Mr. and Mrs. Kuhl have been before the public before recently, a divorce suit having been commenced by the latter

Further Slashing of Rates to the Detroit En-

campment. WABASH AND OTHERS MAY WITHDRAW.

Indication That the West rn Passenger Association Has Finally Struck the Rock on Which it Will Be Wrecked.

Chickson, July 24.-The situation in regard to rates for the Grand Army encampment at Detroit seems to be growing worse every day. When the Western Passenger association meets tomorrow it will find that the complications have increased and that it will be no easy task to straighten out the snarls resulting from the controvercies between Chairman Finley and the Chicago & Alton management: General Passenger Agent Charlton ex-

ploded another bombshell today in the following brief note to Mr. Finley: "Tho Wabash has notified us that it has male a rate of \$5 from St. Louis to Detroit. and return and under the rules of that company all tickets reading via the direct line in either direction between St. Louis and Detroit, may be honored via Chicago. To meet this we shall have to make a rate from St. Louis to Chicago and return of \$5, tickets to be sold July 31 and August 1 and , good going on date of sale and good for return passage to August 18 inclusive. The rule of the Wabash, that its excursion tickets to Detroit and return are good either direct or via Chicago, is prominently aunounced in circulars issued by Grand Army posts in St.

Chairman Finley has authorized the asociation lines to meet any rates made by the Alton. The Atchison gave notice today that t would make a round trip rate of \$5 between Alton. A report was current to the officer that both the Illinois Central and the Wabash had decided to withdraw from the Western Pas-senger association, but the officials of these

roads deny that there is any truth in the story. EXPLANATIONS OF THE WARASH.

The Wabash has withdrawn the coal tariff The Wabash has withdrawn the coal tariff by which it made a rate from Toledo to the Missouri river 50 cents per ton less than the rate via Chiago. The publication of the fact that there was such a tariff in existence caused the Wabash people to send a hasty message to Chairman Finley of the Western Freight association assuring him that the tariff would be shortly withdrawn and that a mistake hast been made. He existence that mistake had been made. He explained that the tariff had been issued as long ago as last September and that when new rates were agreed upon in January, they forgot to with-draw the old rates.

Discriminating Against Omaha.

The general passenger agents of the roads n the Western Passenger association met Wednesday, says the Chicago Tribune, to consider the advisability of meeting the Alton's round-trip \$10 rate between Kansas and Chicago It was decided that inasingch as one of the association roads had met the Alton's rate the \$10 rate should apply on all lines between southwestern Missouri points and Chicago, but that no necessity exists at present for applying that rate between Omaha and Chicigo. This action will arouse bitter feeling on the part of the Omaha peo-

ple, and it is not probable the discrimination against them will be allowed to exist long. There was also a discussion regarding the notice of the Santa Fe that it would make a \$7.50 round-trip rate from Peoria to Niagara Falls, via Chicago, August 9, to meet the rate announced for that date by the Lake Shore and Big Four. Efforts were made to induce the Santa Fe to withdraw that rate, escapes and fire alarms throughout the buildbut without avail. 



Mead, the plumber who was so frightfully burned by an explosion of a gasoline furnace in the Council Bluffs plfmbing company's establishment two weeks ago, caused pretty nearly a sensation among bis fellow workmen and acqurintances. When it was seen that he was without a scar or mark and was as smiling as ever and ready to go to work the wonder partook somewhat of a su-perstitious nature, and the boys eyed the vic-tim of the treacherous gasoline, whom they with this organization, that they will leave more money in Omaha than they take away from it, no matter how great their business may be. 
