CHILIAN PRISON HORRORS

Suspects Tortured in the Most Awful Manner by the Balmacedans.

ONE OF THE VICTIMS TELLS THE TALE.

His Arms Twisted Behind His Back and His Chest Crushed, and Then Flogged Almost to Death.

New York, Aug. 7.—The following personal narrative of the tortures inflicted upon Balmaceda's government upon a suspect, to force him to a confession of complicity with the revolutionary party, is given in a recent issue of the Industrialist.

"Since the passage of the act, up to August 1, I have disclosed, in my office, 8,340 cases brought for Indian depositions in the court of claims, and under the law about five hundred of these have been taken for consideration, under the provisions of the act, and will come up for hearing at the next term of court.

"It is the nature of the claims that the act takes special cognizance of."

"The terms of the act provide for the adjudication of the claims before any other of the national departments."

"The ordinary rules of practice have been applied to Indian depositions cases, as far as applicable."

"It appears that a large number of cases have been taken since the passage of the act, and will come up for hearing at the next term of court."

"When does the court of claims again meet?"

"The court of claims convenes in October next, and at the rate of filing the number of cases of this class will reach five or six thousand by that time."

"The cases range in amount from a few hundred dollars to \$250,000. The latest suit yet brought is in favor of the great representatives of Ben Halliday, the old overland stage man."

"What is the limit of time that claimants have to present their claims?"

"Claimants have three years from the passage of the act to present their claim, so there is no time limit for every one to lay his day in court."

"Are there any special features of the law involving the government's liability in these cases?"

"The law involves many new and important questions as to the liability of the government in respect to the claims of the parties, their heirs or assigns to the unusual interest. The act is one of unusual provision and affects a large number of citizens."

"Do not some of the claims date back twenty or thirty years, and some of them even forty years?"

"The claims in Nebraska, Kansas and the Dakotas are confined mainly to those of the great Sioux nation, or some tribe of the great Sioux nation."

SMOOTH THIEF ARRESTED. He Operated on Steamboats With a False Bottomed Grip.

NEW YORK, Aug. 7.—Valter H. Wyndham of Hartford, Conn., was arrested by Kansas City bankers, a passenger on the steamer Massachusetts from Providence for this city, on Wednesday night was robbed of a russet valise containing \$200.
