FACILITIES FOR CUT-OFF ISLANDERS.

Rules and Grades of Salaries Adopted to Govern Teachers Throughout the Approaching Term-School Book Contract.

The school board held a special meeting last evenin, with all the members present. A petition was introduced asking that a

school be established on Cut-Off Island. It was referred to the chairmen of the commit tee on teachers and the committee on buildngs and grounds. Chairman Schoentgen of the teachers' com

mittee reported that he was not ready to re" port on the assignment of teachers. Stacy reported that the new seats that had been ordered had not arrived yet, and more would probably nave to be ordered, as some of the old ones that had been counted on had

turned out to be too dilapidated to be used. Chairman Hunter of the committee on finance reported the following list of salaries: Superintendent H. W. Sawyer, \$2,000; Principal E. H. Eastman, \$1,200; G. W. Price, \$100 per month; Mrs. Morna Moore, \$75 per month; Miss Janie Baldwin, \$70 per month; Miss Habermans, \$90; Harriet Blood, \$65; Mrs. M. J. O'Neill, \$65. The rest of the salaries ranging from \$40 to \$60 per month, according to the character of the certificates held and the kind of work that had been done by those who had been employed during the past year. A proviso was added that if any teacher should enter into any other business than that for which he was hired by the board it should act as a revocation of their contracts. It was also provided that principals should receive additional pay at the rate of \$5 for the first two rooms under their supervision, and \$1 for each succeeding room. The sal-aries of substitutes was fixed at \$20 per month. The report was adopted unanimously Miss Stelia Baldwin was elected to a posi-

tion as teacher.

President Wells stated that he had entered into contracts with all the publishing firms as authorized, and that they had all given bonds excepting S. C. Griggs & Co., who had refused to do so. He had also placed the order with the latter firm as Superintendent Sawyer had thought it absolutely necessary to have one of the books which was on their

Unfixing the Fees.

He had also appointed Thomas and Richard Green to take charge of the stock of the packing house under his direction. He had succeeded in settling the claim of the First National bank for \$44,490 by paving \$28,000, and the money

to settle the claim had been furnished by the Greens and the assignee, all but \$4,000 being furnished by the latter. He had disposed \$20f the stock under the order of the court to the best possible advantage of all parties concerned. He was put through a crass-examination which took

up the entire morning session. In the afternoon Attorney A. T. Flickinger was put upon the stand and testified to the transactions in connection with the assignnent, substantiating the statements of client, Assignee Hart. In the midst of his cross-examination he was temporarily removed to allow George F. Wright to give his testimony as attorney for the First National bank. He thought that \$3,000 was a small fee for the work that had been done, but when asked just what work had been done by the attorneys for the assignee h could not say, although as he said he would

like to first rate. Flickinger was then put on the stand to finish his testimony. Attorney McCabe, who did the examining, tried to show that Green had done most of the work for which Flick inger was demanding pay, while Flickinger held that his labors alone had resulted in th amicable adjustment of the affairs of the firm. He denied ever having had any conversation with Green with reference to the fee he expected to charge for his services


