THEY WERE ALL AFTER FOX.

Unusual Scope in the District Court Room Yesterday Morning. Judge Estelle Protects the Court. He Saves a Man From Arrest Before the Bench—Fox Charged With Various Offenses—Other Court News.

There was no man in the whole city of Omaha who was more sought after yesterday than Mortimer Fox. The United States authorities wanted Mortimer, the city officers wanted him, and Sheriff Boyd had the pull and landed his prisoner safely in the county jail.

Fox is an innocent looking young fellow of rather flashy appearance and is built somewhat upon the middle order. He arrived in the city some time ago and was arrested by the police. It was charged that he had committed the crime of forgery which a resident of San Francisco, the prisoner's attorney, said and the California authorities notified.

As soon as Officer Sullivan learned that Fox had declared his intention of refusing to go west, he secured a requisition and laid his plans for a speedy return. Fox at once made application for a writ of habeas corpus. The case was argued before Judge Estelle Monday and an opinion handed down yesterday morning.
