What they want is a rate of 50 ents per 100 pounds from Cedar Rapids to the Mississippi river, which would make it less to Chicago, as against the present rate. Traffic Manager Clark, who has just re-turned from an inspecting tour through Iowa, says the stories of ruin to corn crops in that state are exaggerated. His information is that the outlook for a good crop is regarded

as particularly encouraging. More Rate Cutting. CHICAGO, III., May 28 .- Again complaint 18 made that westbound freight rates are demoralized. It is claimed that on freight of the first class the rates from New York to the Missouri river have been cut to 75 or 80 cents per 100 pounds. The western roads that are accused of participating in this reduction are the Missouri Pacific and the Atchison. The cut, if it has really been made, is a serious one. The tariff rate is \$1.37 by the all-rail routes and \$1.26 by the lake and rail lines. First class freight consists chiefly of dry goods and as the shipments of that class of merchandiss are quite heavy during the spring months there is always lively competition among the railreads for the business. It is said that the Burnington and the Chicago, St. Paul & Kansas City are the roads that are complaining. The matter has been brought to the attention of Chairman Midgley and a thorough investigation will be made. The accused roads emphati; cally deny that they have accepted any busi; ness at less than their agreed propor ion

But it is not only on westbound traffic that the charges of rate cutting are made. It is said that the eastbound rates from the Mis-souri river are becoming badly demoralized. One road is accused of having contracted to haul immense quantities of grain from Kan-ass City to Chicago at the Mississippi river rate, which is five cents lower than the tariff rate to Chicago. Furthermore, it is claimed that no satisfaction can be obtained by appealing to the commissioners of the Western Traffic association as by the time relief is granted the guilty road will have pocketed its profits and restored the rate.

Soldiers. Read This!

The Act of June 27, 1890, requires, in the case of a soldier First. A service of at least ninety days in the War of the Rebellion-that is, between March 4, 1861, and August 21, 1868.

Second. A final honorable discharge; but the loss of the certificate is not a bar to a pension, and it need not be filed unless called

Third. A permanent physical or mental disability not due to 'vicious habits." (It need not have originated in the service.)

Fourth. A pensioner under prior laws may apply under this one, or a pensioner under this one may apply under other laws, but cannot draw more than one pension covering the same period Fifth. An applicant under other laws may obtain pension un-

der this one, and at the same time go on with the prosecution of the of

claim. The receipt of a pension under this law does not deprive him of any rights under other laws or in any claim filed previous to this one, or at any time hereafter. He may apply for and be in receipt of a pension under this law while collecting the evidence necessary to prove up any claim he may have under other laws without any prejudide to either claim.

This is not a "Pauper Law," and the pecuniary circumstances of the soldier have no bearing upon his rights. If sufficiently disabled for manual labor, rich and poor are entitled alike. By "manual" labor is meant hard or unskilled labor. Ability to perform skilled or professional labor has no effect upon a soldier's rights.


