Yelled for More Music. The cheers and shouts that accompanied the catchy music was hearty, the band was compelled by the cheers and calls for more to keep the air constantly going for ten min-

Then they played "Dixio" and a hornpipe, and the crowd yelled and cheered. And all the while the rain poured down from a black cloud so dense that without the electric are lights recognition of persons ten feet away would not have been possible in the hall. The lightning was virid and, as a background to the band, music and the din of the con-vention, rattling and booming thunder rolled almost constantly. There crept into the wigwam the tidings of a big fire in some lightning struck structure in the city. The storm penetrated the flat roof of the great convention wigwam, which resembles a Hud-son river lee house, and trickling threads and streams of water fell upon the delegates and spectators. Umbrellas were hoisted all about the hall and the club banners were stowed away for safety. Finally, after nearly three quarters of an hour, Mr. Bragg resumed his speech for Mitchell, Nobody heard it save the stenographer. Oklahoma come under the Stevenson um-

THIRD AND LAST DAY.

Verbatim Report of Yesterday's Proceed-ings of the Convention.

CHICAGO, Ill., June 23,-Jaded, sweaty and languid, the delegates wandered into the convention hall for the last session, a few appearing before 2 o'clock, but the great ma jority falling to put in an appearance until long after the hour set for the opening of the proceedings.

At 2:07 the Gray club of Indianapolis with their velvet banner, on which was inscribed the name of Indiana's governor, marched into the hall preceded by a band playing "Auld Lang Syno," and were received with a yell from the delegates present and the audience. Behind them came the Hendricks ciab of Indianapolis, the members of both clubs flourishing long white plumes and chanting a nondescript air which fitted the words: "Gray, Gray, Isaac P. Gray."

Prayer by Hev. Thomas Green. At 2:55 p. m. Chairman Wilson called the convention to order and the following prayer was offered by Rev. Thomas Green of Iowa: "We thank Thee, Almighty God, for this another day vouchsafed to us. We pray that we may appreciate its possibilities and be true to its responsibilities, and as we come to complete the work that Thou hast given to us to do, we pray snew for Thy direction and guidance. Oh, thou God of battie; thou God of truth; thou God of humanity, may the right be mighty and prevail: Speed thou the people's cause. May the rule of oppres-sion of class and of wealth be broken down. May the rule of humanity on the broad plat form of the Carpenter of Nazareth be tri umphant and prevail; and in this contest may Thy righteousness be everywhere and be established. May those who are to be elected to preside over the people of this great nation be true to our motto, 'That pub-

This was carried with a shout in the midst of a great deal of confusion. The following resolution was offered by Norman E. Resolved, That the name of Hon. W. L. Wilson, permanent chalrman of this convention, be added to the committee appointed by the several states to notify the nominges of this convention of their selection as candidates for the offices of president and vice president of the United States.

Mr. Collins of Massachusetts, who had meanwhile taken the chair, put the resolution, prefacing it as follows: 'On account of the modesty of the permanent chairman I have been requested to put this motion. All in favor of it will say aye, those opposed to it no. The ayes have it."

New York delegation as possible and in the shortest space of time. There Were a Few Cool Heads.

It seemed as if there were no possible way out of a panic, which must have reway out of a panic, which must have resulted in the loss of perhaps hundreds of lives. Fortunately, here and there a cool head remained on its shoulders, and with braced muscles a cordon of brave men surrounded the panke stricken crowd. A wild surge of handanity, which broke over A wild surge of humanity, which broke over the newspaper platform, was promptly met by the warriors of the pencil, and were relied back and held in place until its component parts regained there senses. At length the panic was subdued and the convention proeded with its business.

Adjournment Came Next.

The chairman recognized Mr. Hensel of Pennsylvania, who said: Mr. Chairman. think it must be apparent to all the delegates here that even a roll call of the states cannot now be taken with that deliberation necessary to the proper proceedings of this convention, I therefore move you that the resolution of General Collins be referred to the next national committee with an affirmative recommendation and with power to set. The chairman put the motion to the convention and it was carried.

After the usual resolutions of thanks were adopted, Mr. Russell of Missouri arose and

said: "I move that this convention do now adjourn sine die." The Chairman-Mr. Russell of Missouri moves that this convention do new adjourn sine die. And the chair, thanking the con-vention for its kindness to himself and ask-ing its indulgence for lack of capacity to per-form the duties of the office, hereby declares

the convention adjourned sine die.

Not Interfere, The evidence before the coroner's jury called to investigate the death of 16-year-old Elva Jones, who took a dose of strychnine at her home, 2308 Decatur street, because her parents objected to her intimacy with Charlie Burd, a fireman, showed that four people know that she contemplated taking her own

life and failed to prevent the deed.

Mrs. Johnston tried to get the vial but failed, and promised the girl not to tell anyone but her husband. When her husband came home she told him, and he went off down town to tell Burd. On the way down

he fell in with Miss Hughes, who was on the same evrand. Burd could not loave the en-gine house, and Johnston and Miss Hughes went back to the house next door. had occurred, and after a time Miss Hughe went over and rapped on Eiva's window, calling: "Elva, Elva, don't you do it, don't do it?" and Elva answered in a whisper: "Go away, Hannah, father is coming."

Just then she took the poison which she had dissolved in three glasses of water.

Other evidence showed that the girl was very much in love, and perhaps a little too ealously guarded by her parents and recolted against the restraint. In her letter o ber lover she wrote : Dear Charile: I am going to bid you good ye forever. Always remain as happy as I was when with you. Yours. A verdict of suicide was rendered.
