Some people take great price in being endowed by nature with good hindsight. It is passing strange, nowever, that this community refuses to bank on the foresight of the World-Herold, It opposed the union depot proposition as vigorously as is possible for a paper tha fights with Quaker guns and the proposition carried by about ten to one. Supsequent events have not discredited the judgment pronounced by the people through the tallot box. We have secured a magnificent viaduct across Tenth street at the expense of the railroads. Had they carried out their compact in other respects and given us the union depot as originally designed, and made that depot and the Union Pacific bridge accessible to nil the roads at reasonable tolls, the \$150,000 bonus would have proved a very good investment. As it is, we are no worse off than we had been for twenty years and we have a fair prospect of getting a respectable depot on the site of the old cowshed in the near future without any boaus. If it carries out this project and drives the Nebraska Central out of the field the people who voted the bonds have conferred a great benefit on Omaha If, on the other hand, the Nebraska Central carries out its original program and Omaha shall get two new bridges, two new depots, two new lines to South Omaha and a road through Iowa accessible on reasonable terms to the haif-dozen railroads that are pointing toward Omaha, we shall more than get our money back in the increased traffic and matchless transfer facilities. THE BEE has no disposition to discredit the interstate bridge enterprise. nor does it underrate its value to the future growth of Omaha. The only point we make is that the sudden activity of its promoters, in spite of Union Pacific opposition, tends to create the impression that it is a move designed to block the Nebraska Central in its effort to raise foreign capital. ENTERPRISE IS INVITED.

The fact that the capacity of the Omaha button factory has been doubled within the past sixty days indicates that this young industry is prospering. It also presents an important suggestion that is worthy of attention. If the manafacture of pearl buttons can be profitably carried on here it is reasonable to uppose that manufacturing in scores of other lines would pay equally well in this city. The button makers procure their materials in distant lands. But for the accident that men acquainted with the art of button making came to Omaha to seek their fortunes in other lines of employment that industry would have been among the very last to which attention would have been directed in a city situated thousands of miles from here in the center of the American continent pearl buttons are manufactured from materials brought from Singapore, and it appears that the business is thriving. Any article of commerce that can be manufactured elsewhere can be produced here if enterprise and capital are enlisted for the purpose. An immense territory that can be counted upon as the na ural market of Omaha invites men

here. Hundreds of articles of common

over the great region in which our jobbing houses are carrying on a prosperous business can be produced as profita-

bly in Omaha as anywhere else. This is an old theme, but it does not lose its interest. The idea that this is a good point for manufacturing never has been exploded by failure. There is nothing theoretical or experimental about it. Capable men who have embarked in manufacturing enterprises in this city and elsewhere in this state have not retired from the field in disappointment and discomfiture. It is a practical field that constantly invites endeavor. If one-tenth of the money that is today lying idle in the city of Omaha were wisely invested in manufacturing plants this would soon be a community of wage earners, and upon the wage earning class every city must depend in great measure for its growth in population, wealth and prosperity. Every time a card bearing the words "To Rent" is nailed upon a cottage door -and there are too many of them in Omaha today-a fresh argument in behalf of manufacturing enterprises is brought to public view. The subject deserves the attention of those who are seeking profitable avenues of investment.

AN AUTHORITATIVE APPROVAL Hon. Charles S. Fairchild, who was secretary of the treasury in the administration of Mr. Cleveland and is an ardent supporter of the ex-president, unqualifiedly approves the demand of the democratic national platform for the repeal of the tax on state bank issues. He argues that our citizens are quite capable of dovising and founding banks in the various states and localities which can meet the needs of their people in a manner both safe and elastic, and expresses the opinion that no one need have the least fear of wildcat money from that source.

As Mr. Fairchild stands very high in democratic opinion as a financial authority and is also very close to Mr. Cleveland, his approval of the democratic proposal to restore state bank currency possesses more importance than that of any other democratic leader who has ventured to indorse the demand of the national platform for a return to the old form of currency. It is fair to assume that the ex-secretary of the treasury did not publicly declare his views upon this matter without having previously talked the subject over with the candidate of his party for the presidency, because, as a ligure of some prominence in the campaign, he would desire to say nothing in conflict with the views of the candidate. This leads to the conclusion that Mr. Cleveland is not opposed to a restora-

tion of the state bank currency. The assurance given by Mr. Fairchild that there need be no fear of wildcat money if the states are allowed to issue currency is not likely to be widely accepted with confidence by people who are familiar with the currency of antebellum days, either from personal experience or a study of the financial history of that period. It is true that the later experience of the people with a sound currency everywhere of equal value would cause them to be very careful regarding the money received, but the great majority of the people cannot readily protect themselves against fraud in this direction, and those who would suffer are the people who can least afford it-the small producers and the wage earners. At first state banks would be organized with substantial security for their issues, but this care would gradually wear away and in a few years the country would be flooded with paper currency everywhere at a discount, with numerous counterfeits, and there would be a complete restoration of the old system. The democratic policy in this regard is clearly indefensible and has b en justly characterized as the worst manifestation of financial unsoundness which has emanated

from that party. THE SUBTREASURY PLAN.

The populist party leaders are not saying much about the subtreasury plan, but none the tess it is a cardinal principle of that party-the corner stone, in fact, of its financial policy. Its national platform demands a currency to be issued by the general government and distributed direct to the people "at a tax not to exceed 2 per cent per annum, to be provided as set forth in the subtreasury plan of the farmers alliance, or a better system." At least two bills were introduced in congress by representatives of the new party providing for the establishment of subtreasuries in accordance with this plan, and the populist candidate for president is one of the most earnest advocates of it. The measures before congress propose to appropriate, one \$10,000,000 and the other \$50,000,000, to provide for subtreasuries in all the counties in the United States. upon proper petition, where the cotton, wheat, corn, oats and tobacco produced in the county for the preceding two years exceed \$500,000 or \$200,000, as prescribed in each bill respectively. It is also provided that the owner of products deposited shall receive treasury notes equal at the date of deposit to 80 per cent of the net market value of those products. Storage buildings are to be built by the government, which is to be come selling agent of the depositors.

The populist party professes to be opposed to all class legislation, yet the subtreasury scheme contemplates the worst form of class legislation ever proposed in this country. It would be essentially a vast trust in which the government and the producers of certain products would be co-partners, operat ing not for the general welfare, but for the benefit of the few at the expense of the many. This preposterous plan proposes that certain producers may borrow money from the government upon their products while this privilege is not accorded the producers of other the sources of material supply. Right | products into which there has gone equally as much labor. The wage earner cannot avail himself of this scheme. It would be of no advantage to the professional man. The agricultural producer who had no surplus of cotton, or wheat, or corn, or tobacco, however needy or whatever his situation or demands, could derive no benefit from the subtreasury plan. The populist party professes to be opposed to monopoly, but obviously the application of this scheme of "relief" would result in the greatest and most dangerous of monopolies. If the government should enter into the business of loaning money on farm products and handling them at cost of handling every other person engaged in such business would be compelled to abandon it and seek others. There would be no field for private capital or possibility of competition with the sovereign, who would print money without limit, deciare it legal tender, and by doing business practically at cost monopolize the avenues of trade. Could anything worse be devised, granting it to be practicable, against the interests and welfare of the great body of the people? Admit, for the sake of argument, that the scheme might be helpful to certain producers who could avail themselves of it, but what about the consumers?

And the currency that would be issued to the holders of produce deposited in the subtreasuries, what would that lead to? It is proposed to make it a full legal tender for all debts, public and private. How long would it be before such a currency would expel gold and silver from circulation and become so depreciated that nobody would want it? Is it not perfectly plain that if the government were to undertake to issue such a vast volume of paper currency as would be demanded under the subtreasury plan the effect would be to utterly demoralize the financial system of the country and lead to a condition of affairs which could eventuate only in general ruin and disaster?

Yet this witd, impracticable scheme than which nothing in the whole history of financial vagaries was more ridiculous, is a foundamental part of the policy of the populist party, religiously accepted by most of its adherents as the true solution of the financial and economic difficulties of which they complain. Can it be necessary to say that it would be the greatest possible mistake to entrust to men who can seriously advocate such a policy the power to make and execute laws for an intelligent and progressive people?

AN INSULT TO TAXPAYERS.

The democrats of the Fourth ward have selected a delegation favorable to the nomination of George Whitlock as councilman. The candidacy of Whittock is a brazen piece of impudence and on insult to intelligent taxpayers.

Whitlock has earned the execration of all men, regardless of party. If justice had been done him he would have been indicted for crimical neglect of duty as building inspector in permitting the wall of the Meyer building, under which three persons were crushed to death and several persons crippled, to stand a week after the interior of the building had been burned out. He should have been drummed out of town for his cruel persecution of the late Meyer Hellman. He should be forever barred from any office of profit or trust for helping to logroll the Ketcham furniture job through the city council while he was an officer of the city.

The candidacy of Whitlock is evideatly a put-up job to insure the election of the bogus watchdog, but the citizens of the Fourth ward will repudiate them both and elect somebody who will protect the interests of the taxpayers.

Some idea of the advantages of advertising may be had from the fact that the train loaded with Nebraska products, which is now on its way east, is attracting the attention of thousands of people in every town where it stops. It appears that in the little village of Oneida in Illinois over 400 people have emigrated to Nebraska during the past year in consequence of having seen the exhibits of our advertising train last fail. In another small Illinois town 879 excursion tickets to Nebraska were sold during the past year as a direct result of this form of advertising. The plan of running this year's advertising train over the same route taken last year is certainly a wise one, for it will confirm and emphasize the favorable impressions already made upon the minds of many who contemplate seeking new homes. They will see an exhibit much larger and more diversified than that of last year, and will be impressed with the fact that the resources of this state are only just beginning to be developed. Large results may be confidently expected from this advertising exhibit.

THE Treasury department has just issued its report on education in colleges. comparing the attendance in the different states for the year 1889-90 with the year 1885-86. The report for Nebraska is very encouraging, compared with the records of adjacent states. Iowa's college students have decreased from 2,463 to 1,888; Kansas shows a decrease from 949 to 808, Colorado a decrease from 136 to 119, Illinois from 2,774 to 2,360, and even Pennsylvania shows a slight decrease. Nebraska, on the other hand, has had an increase in her college students of from 406 to 471, and the figures of this coming year will show a much greater gain. In fact, in any respect it is impossible to find anything about Nebraska which does not show gain and progress. Though the device is wholly new to this country, it has been in successful operation in Europe for a considerable time. no reason why it should not prove at least nally useful here. As to the pneumatic tupe system, to which Mr. Wanamaker has devoted much thought, the examining committee has made a preliminary report, recom-mending the immediate construction of a trial line in Philadelphia, so that before lona practical demonstration of its usefulness may be had and such modifications made as may be found necessary for its general adop-tion in the larger cities. This, too, has been a conspicuously successful adjunct to the postal service in Berlin and other foreign cities; and it will undoubtedly win a speedy place in our own service.

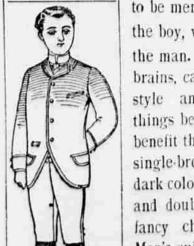
