How the Telegraphers Strike on the Rock Island is Viewed by the Men.

ANJUNE OF WINNING THE FIGHT

Confidence Still Marks the Actions of the Committee—Strikers' Statement of the Situation Along the Line—The Company's Version.

Eleven striking Rock Island operators are now quartered at the Union Depot hotel and a committee is out along the line between this city and Lincoln, skirmishing fratricidal fire brands for that hostility.

The operators claim that their strength and resources, which they say are constantly increasing, have never been fairly recognized. At the Union Depot hotel last night, it was alleged that the striking telegraphers have sufficient money to carry them through the winter, even though the present lavish outlay of money is continued.

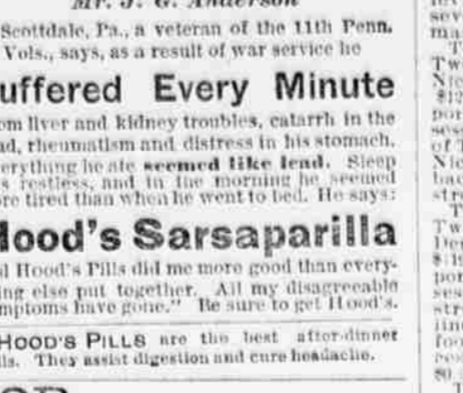
