OUR INTERESTS IN HAWAII

Secretary Foster Defends the Course of Minister Stevens.

HAWAII'S COMMISSIONERS IN WASHINGTON

They Have a Short Interview with Secretary of State Foster The Secretary's Reply to the Minister-Instructions to the Boston's Commander.

Washington, D. C., Feb. 4.-Secretary of State Foster made public the text of the dispatch from Minister Stevens, making known the revolution in Honolulu and his reply. There is nothing new in the former. In reply the secretary approves of the course of Minister Stevens in recognizing the provisional government, and directs him to continue to do so, and to keep himself in communication with the commander of the war ship Boston with a view to protecting the life and property of Americans on the islands. The secretary hopes the change in the government will tend to draw the islands to closer intimate ties of common interest and amity, which so conspicuously and necessarily link them to the United States.

Secretary Foster's Answer.

The secretary also gave out a statement defending the landing of United States ma-rines at Honolulu. This is Secretary Fos-

ter's reply;

Washington, D. C., Jan. 28, 1893.—To John
L. Stevens, United States Minister, Hogolulu,
Care Commander Mare Island Navy Yard, San
Francisco, (al.: Your dispatch relegraphed
from San Francisco, announcing revolution
and establishment of provisional government,
was received today (28). Your course in recognition of an unopposed de facto government
appears to have been discreet and in accordance with the facts. The rule of this government has uniformly been to recognize and
enter into relations with any actual government in full possession of effective power with
the assent of the people. You will continue to
recognize the new government under such conognize the new government under such con-

It is trusted that the change, besides conducing to the tranquility and welfare of the Hawalian islands, will tend to draw closer and more intimate the ties of amity and common interests, which so conspicuously ar sarily ally them to the United States. sarily ally them to the United States. They say it is prob-able that the British minister had met the United States minister on the morning in question and had communicated verbally to him the information that he had just be fore notified the officials of the new govern ment of his recognition, or that he intended doing so. This gave to Mr. Stevens the ground for the statement contained in his dispatch. This is the only way the commis sioners can account for the matter. The matter. The commissioners say they have full power to negotiate a treaty of annexation with the

OPPOSED TO ANNEXATION.

Henry T. Oxnard Talks on the Hawaiian

DENVER, Colo., Feb. 4.-Henry T. Oxnard the beet sugar king of America, who has just returned from Honolulu and is now on his way to New York, in an interview with a representative of the Associated press, said tonight: "The Hawaiian islands can produce and have produced as much sugar as the United States, and this industry has been fostered for the past fifteen years by the United States in this way.

"By treaties with Hawaii all sugare were admitted duty free, and as there was an average duty of over 2 cents per pound on sugars from all other sugar producing countries, the Hawaiians have been selling their sugars at the same price as Cubans and others and did not have to pay the 2 cents duty levied on the Cuban sugar, and in this manner really obtained a bounty of 2 cents per pound on every pound of sugar sent to the United States. This 2 cents per pound did not go into the United States treasury, as did the 2 cents levied en all other sugar imported by the United States, but went directly to the pockets of these very Hawalian planters who are today asking us to annex the Sandwich islands.

In 1890, under the McKinley bill, a bounty of 2 cents per pound was given for sugar pro-duced in the United States from cane, sorghum or sugar beets, and at the same time the duty of 2 cents per pound was removed from imported raw sugar. The immediate result of this was the saving of \$8,000,000 a year, which we had been paying these Hawaiian sugar planters, which is quite enough to pay the bounty on all home produced sugar, and this protection to do-mestic sugar has had the effect of starting the development of the beet sugar industry in the United States in an extraordinary

manner. "If this country shows the same liberality towards her home sugar producers during the next fifteen years as has been shown to wards the Hawaiian planters during the same time, I can confidently assert, without fear of contradiction, that we will save the \$150,000,000 we are annually sending abroad to enrich the farmers, planters and manu-facturers of foreign nations.

"Hawaii employs coolies and the cheapest kind of Chinese labor, and sends their sugar to the Pacific coast to compete against American beet sugar produced at American labor wages. If Hawaii is annexed and they labor wages. If Hawali is annexed and they enjoy the same privileges as American home sugar producers it will greatly injure the new American sugar industry, which is just beginning to develop itself, and which will, in a few years, if not hampered by adverse legislation, find a home in every state of the union, from the Atlantic to the Pacific, either with cane, sorghum or beets.

"They have a strong lobby at Washington, which even includes members of congress, but I do not believe, if only from an economic standpoint, that the United States will want

to burden itself with a territory which has already cost us over \$50,000,000 and would continue to divert \$8,000,000 a year from the United States treasury into the pockets of the new Hawaiian government, otherwise known as the Hawaiian sugar planters. Annexation or nothing is their motto. The reason is evident, as a protectorate would not give them what they are really seeking—money from the United States treasury."

TO OPEN INDIAN LANDS.

South Dakota Clissens Expect to Secure the Yankton Reservation Soon. Stoux City, Ia., Feb. 4.-[Special Tele gram to The Bee.]-Sylvester Walburn, of Armour, was here today and explained the present status of the negotiations for the opening of the Yankton Indian reservaion in Douglas and Charles Mix counties, South Dakota. He says that the commissioners have thus far secured the signatures of 169 of the Indians to the agreement to take land in severalty, In addition to this they have the promise of forty-five more signatures at once. It is necessary to have 192 to secure the necessary majority of all Indians who are heads of families.

The total Indian population of the reserration is 725. Mr. Walburn is confident that the reservation will be opened during the present year, or at least a year from next spring. They anticipate that when the reservation is thrown open there will be such a boom on the occasion of the entrance of the land-seckers as has never been known outside of Oklahoma.

It is also expected that as soon as the reservation is open a branch of the Milwaukee road will be pushed through at either from Yankton or Armour, probably the former, parallel with the river and Union Pacific to Wheeler or some other point in the northern part of Charles Mix county. part of Charles Mix county.
