PARIS, April 27.—The trial of Emile Henri, the anarchist who on February 12 threw a bomb into the cafe beneath the Terminus station, was resumed today in the assizes court of the department of the Seine.

Maitre Hornebois, Henri's defender, has been endeavoring to obtain a three-days release from the prison of Clairvaux of Henri's brother, whom he intends to call as a witness to prove Henri's insanity.
